- vii. Valid ESI No. (for execution of works in WCI/ESI coverage area)
- viii. All intending Bidders who have satisfactorily completed At least 1(one) work of similar nature, costing not less than the amount equal to 50% of the estimated cost under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government during last 5 (five) years are eligible. Completion Certificate indicating Estimated Amount, Value of work-done, Date of completion of the work, and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Statutory Body of Central / State Government will be treated as valid credential.

- G) Neither prospective Bidder nor any of the constituent partners had been barred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertaking/ Enterprise etc during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility.
- H) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.
- I) A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
- J) Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of Earnest Money Deposit (Bid Guarantee).
- K) The bidder at the bidders own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. - L) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.

- N) Prospective applicant is advised to note carefully the minimum qualification criteria before tendering the bids.
