3. Eligibility criteria for participation in tender:

The pre-qualification will be subject to bidder's fulfillment of the qualification criteria set forth and stipulated hereunder & substantiated by authentic and relevant information and details.

The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items as mentioned hereunder.

The bidder shall satisfactorily meet the following qualifying criteria:-

3.1 TECHNICAL CRITERIA:

- a) All categories of intending Bidders who have satisfactorily completed at least one work of similar nature of executed value not less than Rs. 5.48 lakh in a single contract after 1st January'2017.
- b) Similar nature of works for work under sl. no. 3.1(a) shall mean similar type of work like repair & maintenance of quarters/buildings/roads, Construction/Renovation of protection wall/sausage wall/gabion wall, Repair & Maintenance /construction/Renovation of any type of drain/culvert, Execution of any type of road work that contributes towards major financial involvement of the bid.
- c) The bidders must have satisfactorily completed works of similar nature as per above eligibility criteria under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government. Copy of order/s along with completion Certificate/s from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by The bidder along with the credential.
- d) The bidders shall have to submit valid copies of up to date Professional Tax Payment Certificate, Professional Tax deposit challans for last six months, E.P.F. Registration Certificate, GST registration certificate., PAN Card and Income Tax Return Acknowledgement for Assessment Year 2017-18,2018-19, 2019-20, Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License), MSME registration certificate of the bidders, if available.
- e) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- f) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- 4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of The bidder is found qualified by WBSEDCL. The decision of WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.

5. No mobilization advance and secured advance will be allowed.

- 6. A prospective bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If he is found, to have applied severally, in a single job, all his offers will be rejected for that job.
