- 2) Scope of Work: Repair-Maintenance and Oil Filtration of 33/11KV, one no 7.5 MVA Power Transformer bearing serial no: 12691

-: GENERAL CONDITIONS OF CONTRACT :-

1. Contractor's Responsibility:-

Contractor will be solely responsible for any loss of Company's property during his/their tenure of service. He/they shall have to take appropriates precautions to avoid such loss/damage otherwise shall be held reponsible to recover the loss and damage (if any) at his own cost.

2. Contractor's Supervision of work:-

The Contractor shall either present himself personally or deploy his authorized representative for supervision during repair-maintenance work and also keep in touch with controlling officer or his authorized representative for obtaining time to time instruction/direction.

3. Company's Right to Terminate the contract:-

In case the contractor fails to start the work within 30 days of the receipt of Order/L.O.A, or fails to deposit the security money before the stipulated time of 15 days from the receipt of Order/L.O.A, W.B.S.E.D.C.L shall reserve the right to terminate the contract and the security deposit shall be forfeited and the contractor shall have no claim for compensation against the Company for any loss that may incur to him.

During the contract period, if the contractor neglects to proceed with the work with due diligence, the Company shall give 14 days notice in writing to the contractor. After such notice is given the contractor shall not be at liberty to remove from work site any material belonging to him which has been placed thereon for the purpose of the work. If the contractor fails for 14 days after such notice to proceed with the work in the manner notified, the Company shall take possession of the work at the site and engage other persons to proceed further with the work at risk and the cost of the contractor. In such an event, the Company shall be entitled to notify the contractor to remove within 7 days all materials or stores belonging to him from the location and the contract shall be liable to be terminated without stating any reason thereof and the security deposit shall be forfeited. In case the contract is terminated as above, the contractor shall have no claim for compensation against the Company for any loss that may incur to him. In case of termination/completion of contract, W.B.S.E.D.C.L will have no responsibility regarding any claim of you and /or your employed workers.

4. Commencement of work:-

The date of Commencement of work shall be within 15 days of agreement made.

5. Credentials:-

The Agency/ Contractor should provide credentials for execution of similar type of work in last 5 years in Govt./Semi-Govt./PSU/Private Organisations, etc. The agency/contractor shall have to furnish copy of work order to justify their credential and performance certificate from the employer. The contractor/agency should have G.S.T, Professional Tax, Income Tax and must have PAN, Labour License & PF registration.Copies to be submitted.

6. Insurance for Workmen's Compensation:-

You will have to submit Insurance Policy for all the workmen to be engaged by you according to the "Workmen's Compensation Act, 1923" and the rules made there under. Thereby the Company shall not be liable for any compensation in case of any accident or untoward incident of your staff during contarct period and whilst executing the repair-maintenance work on Power Transformer.

7. Disputes:-

In case of any dispute arises between you and W.B.S.E.D.C.L, the same shall have to be settled mutually and in the event that such can not be done, the matter shall be under jurisdictions of Purulia District Court only.

8. Controlling Officer:-

The Addl. Chief Engineer & Project Site Incharge, PPSP Site, WBSEDCL, Bagmundi, Purulia -723152 or his authorized representative, is the Controlling Officer.

9. Supervising Officer:-

The Superintending Engineer (E), OPH, PPSP Site, WBSEDCL, Bagmundi, Purulia-723152 or his authorized representative, is the Supervising Officer.

10. Paying Authority:-

The Assistant Manger (F& A), PPSP Site WBSEDCL, Bagmundi, Purulia -723152

11. W.B.S.E.D.C.L Right:-

WBSEDCL reserve the right to reject any or all tender(s) without assigning any reason whatsoever and does not blind it to accept the lowest bidder/Offer.

12. Site Visit:

Intending Bidder may visit PPSP Site at their own cost before submission of their offer for better understanding of the site conditions.

13. Pre- Bid discussion:-

Pre-Bid discussion will be held at Purulia Pumped Storage Project Site, WBSEDCL, Bagmundi, Purulia, as per schedule indicated, to clarify the queries, if any, from the bidders in respect of Tender. Interested bidders who shall participate in the bid may join (maximum two persons) in the said meeting for any such clarification.

14. Raw Materials:-

Materials to be supplied by the repairer should be strictly conforming to the specification indicated in Schedule of work. The Company shall not take any responsibility for procurement of any raw materials from any of the Government/Semi-Government agencies.

15. Force Majeure:-

The repairer shall be under no liability if they prevented from carrying out of their obligations and reasons of war, invasion, act of foreign money, hostilities (whether ware declared or not) riots, civil commotions, mutiny, insurrection, rebellion, revolution, accident, earthquake, fire, flood, Government order and/ or restrictions (except power supply restriction), delay or inability to obtain materials due to import or other statutory restriction or other causes beyond the reasonable control of the repairer. However, such Force Majeure circumstances are to be intimated immediately and to be established subsequently with proper documents/proof to the entire satisfaction of the Company.

16. The repairer should undertake the items/quantity not mentioned in the schedule as per instruction of supervising officer or his authorised representative to finish the repairing job upto the satisfaction if W.B.S.E.D.C.L for proper performance of the Power Transformer. The rate of these additional items if any would be settled on mutually agreed rate with complete justification /existing rate contract of W.B.S.E.D.C.L/P.W.D (E) rate contract as the case may be.

Annexure-II

TECHNICAL SPECIFICATION:-

- 1. The Repairer shall have a team of Engineers/Supervisiors/ Skilled Labours with technical qualification and experience in the similar profession.
- 2. The Repairer shall arrange necessary storage area for safe keeping all the materials, instruments for carrying out the repair-maintenance job.
- 3. The repairer shall have their own testing instruments for keeping records of all the requisite parameter before and after the repair-maintenance job to ascertain the improvement of health of the Power Transformer.
- 4. All the machinery/ Tools & Tackles required undertake the repair-maintenance job shall have to be arranged by the repairer at their cost & responsibility.
- 5. The Drain out of Transformer Oil from the Power Transformer should be stored in the Drums to be provided by the repairer and properly numbered for identification of Old & used Transformer Oil to return to PPSP Store, Drums/barrels in which new oil shall be supplied by the W.B.S.E.D.C.L shall be adjusted with the repairer Drums/Barrels. Remaining barrels shall not be taken back and the cost of barrels/drums shall be recovered from the repairing bill.
- 6. Repairer shall notify the Supervising Officer/or his authorized representative well in advance about the readiness of the Transformer show that testing unit can arrange programme for testing of complete Transformer on mutulaly agrred date in consultation with the Controlling Officer. The testing unit reserve the right to reject either raw materials or finished assembly found to be not complying with the requirement of the specification.
