- I. **Delivery of material:** Within 45 (Forty Five) days from the date of issuance of the order.
- II. **Place of delivery:** Delivery instructions for the material - will be delivered to the Chief Engineer, Distribution Testing Department (DTD), WBSEDCL, at Abhikshan Bhavan, Block-DD, Salt Lake, Kolkata, West Bengal 700064, for testing. Following successful testing, the materials will require to be delivered to the PPSP Site Store, WBSEDCL, Bagmundi, Purulia, West Bengal 723114.
- III. **E-Way Bill :** The generation of E-way Bills for all goods supplied under this tender, shall lie with the Bidder/Contractor. This includes situations where the goods are supplied to the Tender Inviting Authority's premises or to any other designated location."if Required.
- IV. **Transit insurance :** The bidder shall be exclusively responsible for procuring and maintaining comprehensive transit insurance for all goods, materials.
- V. **Price:** Price should be firm inclusive of all incidental charges. GST value and percentage to be written separately in quotation. However, GST will be applicable as per law of land at the time of placement of order. STDS will be deducted as per norms.
- VI. **Delivery Charge:** Delivery charge will be borne by the Agency.
- VII. **Payment:** Ninety percent (90%) of the contract value will be paid preferably within 45 (Forty-Five) Days after successful delivery and acceptance of materials. Ten percent (10%) will be retained as Security Deposit (SD) and will be refunded after expiry of the guarantee/warranty period on receiving application from the vendor. Materials will be received at site through raising Store Receipt Voucher (SRV). Bills in triplicate along with challan in triplicate and advance pre-receipt copy with revenue stamp must be given by the Agency at time of delivery. In case of part delivery of materials payment will be made accordingly. Payment will be made through R.T.G.S/N.E.F. T (R.T.G.S/N.E.F. T charge to be borne by the Agency).
- VIII. **BG/BD :** 10 % of the quoted value as additional performance security will have to deposited , if the bidder quotes in the range of -20% to -80% .

- XII. **Liquidate Damage:** Penalty for delay in work @1/2% (Half percent) of value of order for each week delay or part thereof upto ten (10) weeks and @1% of the order value per week or part thereof beyond ten (10) weeks subject to maximum limit of 10% (Ten percent) will be deducted from your bill.
- XIII. **Guarantee/Warranty:**Original manufacturer guarantee/warranty or 12 months whichever is greater is to be provided for equipments and materials. In case the supply materials are beyond our specification or found defective/damage /broken within **declared Guarantee/Warranty period** from the date of delivery of materials, the same should be replaced by you at your own cost and responsibility.

- XV. **Validity:** The offer must remain valid for **120 days** from the date of opening of the Tender.
