NOTICE INVITING e-TENDER

Tenders are invited by the Addl. Chief Engineer and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., Phansidewa, Darjeeling-734434 through electronic tendering (e-tendering) from **Original Equipment Manufacturer (OEM) or authorised dealer of the OEM.**

- 1. Name of the work:** Supply, installation, testing & commissioning of 220V, 300Ah \pm 1% Plante Type Lead-Acid Flooded Stationary Battery Bank in Transparent SAN Container for critical standby application (High Discharge Performance), consisting of 110 numbers of batteries of 2V each at O&M Division-I, Teesta Canal Fall Hydel Project under WBSEDCL.
- 2. Completion Time:** The entire work for supply, installation, testing & commissioning of the batteries shall be completed within 18 (eighteen) weeks from the zero date. The zero date will be reckoned the date of receive of L.O.A vide (A) by hand (B) by e-mail or any electronic media and (C) by post, whichever is earlier.
- 3. Price Basis:** The Price shall be quoted on FOR O&M Division-I, TCFHP site basis including all charges towards freight & transit insurance, packing & forwarding etc. GST will be paid extra as per actual. The quoted prices shall remain FIRM during the currency of the contract.
- 4. Estimated cost-**The estimated cost of proposed work is Rs 2327700.00
- 5. Earnest Money Deposit:** ₹ 58200/- (Rupees Fifty Eight Thousand two hundred only). All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>) online. Details regarding the same are narrated in "B. Instructions to the Bidders". As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.



The EMD may also be submitted in form of Bank Guarantee (BG) in the format as in **Form-IV** valid for a period of 180 (one hundred eighty) days from the date of opening of techno-commercial bid with additional claim period of 90 (ninety) days. Tender without Earnest Money Deposit shall be rejected summarily.

6. Eligibility Criteria: The intending bidders must have:

- i) Bidder must be an Original Equipment Manufacturer (OEM)/ Authorised dealer of the OEM.
- ii) The OEM should have minimum existence in design, manufacture, supply, installation, testing & commissioning of batteries for the last 7 years.
- iii) The OEM must provide good performance certificate for at least two nos. of similar installation in any Government department / PSU / Power Utility / any corporate entity in the last seven years. The OEM shall have offices equipped with the required instruments and properly trained personnel for taking care of after sales service throughout the expected life of the equipment. Similar work shall mean supply and installation of 220V, 300Ah (or higher capacity) Plante lead acid battery bank to any Government department/ PSU/ Power Utility / any corporate entity.
- iv) The authorised dealer must arrange documentary evidence from OEM for fulfilling the criteria as mentioned in Clause No. 6 (ii) and 6 (iii). Any bid submitted by a dealer without such documentary evidences will be summarily rejected.
- v) The bidders Minimum Average Annual Turnover (MAAT) for best one (01) year out of the last five (05) financial years should be ₹ 12,00,000/- (Rupees Twelve Lakh Only).
- vi) Valid GST Registration certificate and GST return of last two financial year ending 31st March, 2025 (GSTR3B / GSTR9).
- vii) PAN Card.
- viii) Audited annual Accounts of the Company for the last 03 (three) years (in case of companies) or IT return duly acknowledged by the Income tax department for the last 03 (three) years (in case of bidders other than company).
- ix) Trade License in respect of the prospective Bidder. Proprietorship Firm (Trade License). Partnership Firm (Partnership Deed, Trade License). Ltd Company (Incorporation certificate, Trade License). Co-operative Society (Society Registration copy, Trade License). [Non-statutory Documents].
- x) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt. /Govt.


