### **A. NOTICE INVITING e-TENDER**

Tenders are invited by the Additional Chief Engineer and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., P.O. Phansidewa, Darjeeling - 734434 through electronic tendering (e-tendering) from from bonafied, resourceful, experienced and financially sound Indian firms, on "percentage basis".

1. **Name of the work:** Resolving the issues of water leakage from discharge Ring , oil leakage from guide vane servomotor, huge water leakage from Shaft Seal , Operational problem of Guide Vanes & Dismantling, retrofitting and installation of oil/air actuator of different installed TG units under TCFHP as per enclosed work schedule.
2. **Estimated Amount:** ₹ 1,12,50,000/ (Rupees one crore twelve lakh fifty thousand only) excluding GST.
3. **Earnest Money Deposit:** ₹ 2,81,250- (Rupees two lakh eighty one thousand two hundred fifty only). All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenenders.gov.in>) online. Details regarding the same are narrated in "B. Instructions to the Bidders". As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.
4. **Completion Period:** The work as per the detailed Schedule of Work in all respect shall be completed within 60 (sixty) days from the date of handing over the site.
5. **Eligibility criteria for participation in tender:**
  - i) Average annual financial turn over during the last three years, ending 31st March of the previous financial year, should be at least 50% of the estimated cost.
  - ii) Experience of having successfully completed similar works i.e repair and servicing/AMC of electro/mechanical hydro equipments of minimum 5 MW TG(Turbine Generator) Hydel units during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:
    - (A) Three similar completed works costing not less than the amount equal to 40% of the estimated cost or

(B) Two similar completed works costing not less than the amount equal to 50% of the estimated cost or

(C) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

iii) PAN Card.

iv) Valid GST Registration certificate and GSTR3B or Annual return- GSTR9 for last two years.

v) Up to date Professional Tax enrolment certificate.

vi) P.F. Registration number.

vii) Audited annual Accounts of the Company for the last 03 (three) years (in case of companies) or IT return duly acknowledged by the Income tax department for the last 03 (three) years (in case of bidders other than company).

viii) Trade License in respect of the prospective Bidder. Proprietorship Firm (Trade License). Partnership Firm (Partnership Deed, Trade License). Ltd Company (Incorporation certificate, Trade License). Co-operative Society (Society Registration copy, Trade License). [Non-statutory Documents].

ix) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt. /Govt. Undertakings/ Enterprise etc. during the last 05 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents].

x) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 05 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents].

xi) No conditional / Incomplete Tender will be accepted under any circumstances.
