The original Demand Draft / Banker Cheque against tender fees, Earnest Money should be submitted physically at Burdwan Region Office. Administrative Building , 1st floor, Power House, Bardhaman, District Purba Bardhaman Pin-713101 under sealed cover with due date & time of submission of Bid.
- 2. Both Technical Bid and Financial Bid should be submitted in technical and financial folder concurrently duly digitally signed by the Bidders through the website https://wbtenders.gov.in.
- 3. Technical Document and Financial Bid should be submitted online on or before 04.01.2020 up to 17:00 Hrs
- 4. The FINANCIAL OFFER of the prospective bidders will be considered only if the TECHNICAL DOCUMENT of the bidders found qualified by the Tender Inviting Authority(WBSEDCL). The decision of the Tender Inviting Authority (WBSEDCL) will be final and absolute in this respect. The list of Responsive and Non-Responsive Bidders will be displayed in the website.

- Eligibility criteria for participation in the tender: 5.
 - 5.1. <u>Technical Requirement</u>:-Bonafide, experienced & resourceful agency who is technically qualified & have successfully completed similar nature of work in a Single contracts within last 3 years subject to fulfillment of following criteria:
 - a) One similar completed works costing not less than the amount equal to 50% of the estimated cost.

5.2. Commercial Requirement: -

Annual audited Financial Report for last three years to be submitted for verification i.r.o bidders for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT return along with related enclosures (Form 3CA and Form 3CB) for last three years.

5.3. Statutory Requirement:-

- i) Valid copies of current G S.T. certificate,
- ii) Authorised dealership certificate of the company.
- iii) Current Challan for depositing Professional Tax (PT)
- iv) Service Tax Registration certificates
- v) Certificate of compliance of statutory obligations (to be documented through e-filing).
- vi) Copy of IT return for last three financial years, PAN Card, as applicable.
- vii) Documents in support of credential: Copy of orders & Completion Certificate
- ix) Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt./PSU in which the bidder is involved, the party is concerned and disputed amount, wherever applicable.
- 6. No mobilization / secured advance will be allowed.
- 7. Bids shall remain valid for a period not less than 180 (One Hundred Eighty) days after date of bid opening of tender. Bid valid for a shorter period shall be rejected by the Tender Inviting Authority as non-responsive. If the bidders withdraw the bid before the period of bid validity without giving any satisfactory explanation for such withdrawals, the Earnest Money as deposited will be forfeited forthwith without assigning any reason thereof.

Earnest Money shall have to be deposited in a separate cover @ 2% of the estimated cost in the form Of Demand Draft/Bankers Cheque/Pay Order on any scheduled Commercial Bank in favour of WBSEDCL and payable at Burdwan

- The bidder shall submit along with the offer necessary documents in support of their previous such type of 10.0 work/ tender/ similar items to WBSEDCL/Other Power Utilities/Other Govt. Departments in earlier occasions and financial capabilities to the extent of the estimated financial amount of their offer.
- WBSEDCL reserves its right to take decision keeping its financial interest. 11.0
- If the offer is submitted without or inadequate Earnest Money, the bid will not be opened. In case of 12.0

incomplete offer, the tender will be liable for rejection and Earnest Money Deposit will be forfeited. The offer shall remain valid for a minimum period of 120 days from the next day of opening of the tender.

- 13.0 At the time of placing purchase order, the quantity mentioned in the Tender Document may vary up to ± 25%.
