1. Intending bidder should download the tender documents from the website <http://www.wbtenders.gov.in> directly with the help of Digital Signature Certificate. Necessary cost of tender documents (tender fees) & Earnest Money Deposit (EMD) should be remitted separately through Demand Draft issued from any scheduled bank in favour of the "West Bengal State Electricity Distribution Company Limited", payable at Kolkata and the same should be documented and scan copy of the aforesaid documents are to be uploaded through said website as per schedule stated in Sl. No. 10 (Details of which has been narrated in the Instruction to the Bidders). The original Demand Draft/Pay order against Earnest Money Deposit(EMD) should be submitted physically by the Bidder at Darjeeling



Regional Office, 3<sup>rd</sup> Floor Administrative Building, Powerhouse Complex WBSEDCL, 2<sup>nd</sup> Mile Sevoke Road , Siliguri-734001 under sealed cover accompanying NIT number should be mentioned on the envelope.

2. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbtenders.gov.in>. (Details of which has been narrated in 'Instruction to Bidders'). Technical Document and Financial Bid should be submitted online on or before as per the 'Date & Time Schedule' stated in Sl. No.-10.

**3. Eligibility criteria for participation intender:**

i) All categories of intending Bidders who have satisfactorily completed at least one similar nature of work under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government of executed value not less than 50% of estimated cost in a single contract during last 3 (three) years. Copy of Erection Order/ L.O.A of similar nature of work i.f.o. the Contractor/Agency, accordingly copy of Completion and Payment Certificate, and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential.

ii) All categories of prospective Bidders shall have to furnish **the self-attested copy** of the following documents:

- a) GST registration certificate
- b) PAN Card.
- c) EPF registration certificate
- d) E.S.I. registration certificate
- e) Electrical Contractor's License & Electrical Supervisor's Certificate with validity
- f) I.T Return for last three financial years (2017-18, 2018-19, 2019-20)
- g) Professional tax deposit challan for last month

iii) Neither prospective bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt/Govt Undertakings/ Enterprise etc during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents]

iv) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents]

v) The intending bidders are required to quote the rate online.

4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified/ Responsive and Disqualified/ Non-responsive Bidders of Technical Bid will be displayed in the website.

5. No mobilization advance and secured advance will be allowed.

6. Constructional Labor Welfare Cess @ 1% (one percent) of cost of construction will be deducted from every Bill of the selected agency, Royalty & all other statutory levy / Cess will have to be borne by the contractor & the rate quoted by the contractor percentage is inclusive of all such taxes and cess as stated above excluding Goods and Services Tax.

7. **Bid Validation:** Bid shall remain valid for a period not less than 180 (One hundred and eighty) days after date of Bid opening of tender. If the Bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit(EMD).

8. **Earnest Money:** The amount of Earnest money @ 2% of the estimated amount i.e Rs.143110.00 (Rupees One lakh forty three thousand one hundred ten only) for Sl no. 1 and Rs. 60123.00 (Rupees sixty thousand one hundred



twenty three only) for SI No. 2. put to tender in the shape of Bank Draft or Pay order of any Scheduled Bank to be drawn in favour of the "West Bengal State Electricity Distribution Company Limited" payable at Siliguri. Earnest Money of the unsuccessful Bidder will be released after finalization of tender against the prayer of the contractor. No interest shall be payable by WBSEDCL on the above Bid guarantee.

9. **Performance Guarantee:** The bidder will submit Bank Guarantee on Non-Judicial Stamp paper of Rs. 100/- by any Schedule Bank in India, as per format enclosed (ANNEXURE-IV) for an amount of 10% of the order value within 15 days from the date of placement of Purchase Order to the Divisional Manager, Siliguri Sub-Urban Division. No claim shall be made against the company in respect of interest on the Performance BG. The Performance Security Deposit is liable to be encashed in case of non-compliance to the Purchase Order or failure to undertake satisfactory UG Cable laying work. The BG shall be valid for one year after completion of the contract period of three months with a claim period of further three months. The validity of Performance Bank guarantee will be 15 months with a claim period of further 3 months.

11. **Specification of Work:** The work should confirm to WBSEDCL's general conditions of contract and satisfying relevant provisions of I.E.rules.

12. **Tools & Tackles:** You shall be equipped with reliable sets of tools and tackles in sufficient quantities so as to complete the work entrusted with you as expeditiously as possible.

#### 13. Penalty for delay in Completion:

13.1 If the contractor fails to complete the work successfully within the time specified in the contract or any extension thereof, the company shall recover from the contractor as liquidated damages as up to half percent(0.5%)of the contract value of works for each calendar week of delay or part thereof of delay subjected to Force Majeure.

13.2 The total recovery against liquidated damage shall not exceed ten percent(10%)of the contract value of the work. An extension of time without imposition of liquidated damage, may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted by the contractor who has to establish that the extension of time required by him was not due to his fault.

14. The Bidder at the Bidders own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The costs of visiting the site shall be at the Bidders own expense.



15. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.

16. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in "Instructions to Bidders" stated in Section 6 (Submission of Tenders) before tendering the bids.

17. Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances.

18. Conditional / Incomplete tender/ bid will not be accepted under any circumstances.

19. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.


20. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
