 - The Bidder shall have the experience of replacement of runner of any kind in any hydel or thermal power projects operated by any central, state or private power utility for an order value amounting minimum fifty percent (50%) of this estimated price in last five (05) years.

In support of the above, the bidders shall submit the Letter of Award (LOA) and/or Delivery Certificate duly signed by respective ordering authority.

The Bidder shall produce original copy of the documents i.r.o. eligibility criteria, if so, required by WBSEDCL. Any discrepancies found by the tender inviting authority may lead to rejection of the bid and forfeiture of the earnest money.

7. Validity: The tender shall be valid for one hundred and eighty (180) days from the date of opening of technical bid.

8. Conditional / Incomplete tender will not be accepted under any circumstances.

9. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

10. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is either incorrect / manufactured / fabricated or false at any stage, his Tender will be rejected and legal action may be taken against him.

11. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves its right to take decision keeping its financial interest.

12. WBSEDCL reserves the right to:

- Amend the scope of work to be tendered.
- Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and
- Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.
