Such abandonment or rescission will be considered as disqualification towards eligibility. (a declaration in this respect has to be furnished by the prospective bidders).
- (v) No conditional / Incomplete Tender will be accepted under any circumstances.
3. Intending bidders may visit the site giving prior intimation to the office before submission of tender.
4. **Bid Guarantee (Earnest Money deposit):** The bid must be accompanied by earnest money deposit (EMD) of **Rs. 4,200** /-(Rupees four thousand two hundred only) as bid guarantee, failing which the bid shall be considered as non-responsive and hence liable for rejection. Bid guarantee (EMD) shall be submitted in a separate sealed envelope payable either through **Banker's Cheque (BC)/ Demand Draft (DD)** issued from any scheduled commercial bank of India, approved by RBI, in favour of "WEST BENGAL STATE ELECTRICITY DISTRIBUTION COMPANY LIMITED " payable at Siliguri.
