2. All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level. (Details are narrated at Sl. 14 in 'Instructions to Bidders' at Section-B.) The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>) online. As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However, for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.
3. Both the **Technical Bid** and **Financial Bid** are to be submitted concurrently for each e-tender duly signed digitally by the Bidder through the website <https://wbtenders.gov.in> and should be submitted online on or before the prescribed dates as per the 'Date & Time Schedule' stated in Sl. No.:9.
4. **ELIGIBILITY CRITERIA FOR PARTICIPATION IN e-TENDER (For each e-Tenders):**
 - (i) The bidder must have successfully completed 'similar' works i.e., "any work related to **Civil construction / maintenance / operation in hydro power plants**" during last 7 (seven) years (i.e., Date of Completion should be on or after **31.08.2018**) under the authority of State/Central Government, State/Central Government Undertakings, Statutory Bodies constituted under the statute of Central/State Government, subject to fulfillment of the following criteria:
 - (a) Three similar completed works each costing not less than 40% of the total estimated cost in a single contract,
 - OR
 - (b) Two similar completed works each costing not less than 50% of the total estimated cost in a single contract,
 - OR
 - (c) One similar completed work costing not less than 80% of the total estimated cost in a single contract.
 - (ii) The Minimum Average Annual Turnover (MAAT) for last 03 (three) Financial Years (i.e., FY 2023-24, 2022-23 and 2021-22) shall not be less than 30% of the estimated cost.
 - (iii) The working capital of the bidder in the preceding year of bid submission i.e. FY 2023-24 shall not be less than 30% of the estimated cost.
 - (iv) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in clause no. 4. (ii) above, shall be judged by adding available credit facility and working capital taken together.
 - (v) Annual Audited / Certified Financial Report along with related enclosures for last 3(three) years i.e. FY 2023-24, 2022-23 & 2022-21 (or AY 2024-25, 2023-24 & 2022-23) is to be submitted for verification.
 - (vi) Completion Certificate indicating Executed Amount, Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned

(vii) All categories of prospective Bidders shall have to submit valid copies of Professional Tax Payment Challan for the last 6 months, E.P.F. Registration certificate, GST Registration certificate, E.S.I. Registration certificate, PAN and Income Tax Return (ITR) Acknowledgement for **Assessment Year (AY) 2024-25, 2023-24, 2022-23**, Trade License in respect of the prospective bidder for Proprietorship Firm, Trade License+ Partnership Deed for Partnership Firm, Trade License + Incorporation certificate for Limited Company and Trade License + Society Registration copy for Co-operative Society. **[Non-statutory Documents]**

(viii) Neither prospective Bidder nor any of the constituent partners had been barred to participate in any Tender by any Government Department / Semi - Govt. / Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIET. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). **[Non-statutory Documents]**

(ix) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). **[Non-statutory Documents]**

(x) No conditional / Incomplete Tender will be accepted under any circumstances.

5. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. List of Technically Qualified Bidders will be uploaded in the website for each e-tender separately.

6. **No mobilization advance and secured advance will be allowed.**

7. The prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If any of the bidders found to have applied severally for a single job, all his offers will be rejected for that job. No agent is allowed to participate in the tender. Original contractor will only be allowed to participate in the tender.

8. Bid shall remain valid for a period not less than **180 (one hundred eighty)** days from the date of opening of Financial Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

The Bidder at the Bidder's own responsibility and risk is encouraged to visit and examine the sites of the works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the Bidder's own expense.
11. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
12. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section - 'B' before tendering the bids.
13. **Exemption from deposition of earnest money (EMD) shall not be allowed under any circumstances.**
14. The intending Bidders are required to quote the rates online in **percentage basis** as per specified format/B.O.Q.
15. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not allowed to participate in the tender and that application will be rejected without any prejudice.
16. The Canvassing in connection with tender submitted is strictly prohibited.
17. **The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is found to be incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.**
18. **The eligibility of a bidder will also be ascertained on the basis of his/their recent past performances in other allotted works (on-going or completed). The WBSEDCL reserves the right to reject those bidders whose performance in the recent past was not satisfactory and no claim in this respect will be entertained.**
19. **Time is the essence of this contract. If the successful bidders to whom the contracts will be awarded, fail to complete the work within the scheduled completion period of 60 days an additional penalty @ 10% of the ordered value will be deducted from their final bills beyond the Liquidated Damage (LD) and no claim in this respect will be entertained as well.**
20. The participating bidders may please note that the successful bidder shall have to execute and submit a **Contract Agreement** and an **Indemnity Bond** in the prescribed format before commencement of the work together with submission of required performance guarantee.
