**Terms & conditions of the Tender Notice:**

1. (a) **Earnest Money Deposit** amounting to 2.0% (Two Percent) of the Estimated Cost. As mentioned above, shall be submitted individually along with the offer. Necessary earnest money shall be remitted through online mode of opted for BG.  
(b) **Forfeiture of Earnest Money Deposit (EMD):** Earnest money deposit / bid guarantee shall be forfeited in case of the following situations:
  - (i) If during the period of validity, the bidder withdraws modifies its bid as a whole or in part.
  - (ii) If the bidder deviates from any clarification/confirmation given by him subsequent to the submission of their bid.
  - (iii) If the offer is submitted without or inadequate Earnest Money, the bid will not be opened. In case of incomplete offer the tender will be liable for rejection and Earnest Money Deposit will be forfeited.
  - (iv) In the case of successful bid, if the bidder fails to:
    - Accept the Letter of Award (LOA) Order unconditionally and sign the contract
    - Furnish the Contract Performance Bond as per the standard proforma.
2. The bidder shall submit along with the offer necessary documents in support of their previous supply. Of the items of the tender to WBSEDCL in earlier. Occasions and financial capabilities to the extent of the estimated financial amount of their offer.
3. Successful bidder(s) shall have to mandate only create Vendor ID through WBSEDCL Web Portal Vendor Corner, if not created earlier.
4. Original manufacturer/Distributors of the tendered item will be eligible in the tender and must submit Dealership certificate in PDF format. No agent is allowed to participate in the Tender.
5. WBSEDCL reserves its right to take decision keeping its financial interest. The Purchase Policy of WBSEDCL along with the provisions of Vendor Rating & Holiday Listing, as effective from 01.09.2012 and the subsequent amendment effective from 18.03.2013 will be applicable.
6. If the offer is submitted without or inadequate Earnest Money, the bid will not be opened. In case of Incomplete offer, the tender will be liable for rejection and Earnest Money Deposit will be forfeited.
7. **One Unit Sample of Each Material is to be submitted at Khatra Divisional Store physically as per the date and time schedule of tender.** The tag with the sample should contain the name of the sample as well as the name of the vendor/bidder, for a valid tender, sample has to be approved by the Divisional Authority. - a. Technical Requirement:- Bonafide, experienced & resourceful contractors of Govt., Semi Govt., Govt. undertaking Organizations, Govt. Enterprises, Other Licensee of States, etc. who is technically qualified & have successfully completed similar nature of work having value not less than 80%/50%/40% (Eighty/Fifty/Forty percent) of the estimated cost in a Single/Two/Three contracts respectively during last 7 (Seven) years.
- b. Commercial Requirement: - a) Average annual turnover during last three years. b) Annual audited Financial Report for last three years to be submitted for verification i.e. bidders for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT return along with related enclosures for last three years.
- c. All intending bidders are required to also produce the following:-
  - i) Valid copies of GST Registration
  - ii) Current Challan for depositing Professional Tax (PT)
  - iii) Copy of IT return for last three financial years, PAN Card, as applicable.
  - iv) Trade Licence
  - v) Documents in support of credential: Copy of orders & Completion Certificate/Material Receipt Copy from store.
  - vi) Performance Certificate as Prime Contractor for execution of similar nature of works for last Seven and details of works in hand.
  - vii) Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt./PSU in which the bidder is involved, the party is concerned and disputed amount, wherever applicable.

26. No mobilization / secured advance will be allowed.

27. Receiving of Earnest Money Deposit (EMD):- The amount of Earnest Money as given is to be submitted through ON LINE process only.

28. Return of Earnest Money of unsuccessful bidder(s):- The Earnest Money of all the unsuccessful bidder(s) deposited along with the Tenders will be refunded as per norms and without any interest.

30.
