Name of Work: Developement of electrical infrastructure by laying of 11kv UG cable from Bolpur 33/11kv Sstn to Bolpur Industrial Park Phase -2 at Sian Under Bolpur Division.

The Regional Manager, Birbhum, Regional Office, WBSEDCL invites e-Tender in Two-Part only from the Bonefied, experienced & resourceful contractors of Govt., Semi Govt., Govt. undertaking Organizations, Govt. Enterprises etc. who is technically & commercially qualified and have successfully completed similar nature of work having value not less than 50%/40%/30% (Fifty/Forty/Thirty percent) of the estimated cost in a Single/Two/Three contract during last 7 (Seven) years and Commercial QR as detailed in clause 5.2 below. [Submission of Bid through online]

1. In the event of e-filing intending bidder may download the tender document from the website <https://wbtenders.gov.in> indirectly with the help of Digital Signature Certificate.
 - a. A bidder desirous of taking part in the tender shall login to the e-Procurement portal of Government of West Bengal <https://wbtenders.gov.in> using his login Id and password.
 - b. The bidder shall select the tender to bid and initiate payment of BID SECURITY. Following payment options are available for paying BID SECURITY amount through online mode:
 - i. Net banking through Payment Gateway.
 - ii. **RTGS/NEFT payment:** On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details of process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.
 - c. BID SECURITY amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. Partial payment through online mode and remaining submission through BG is not allowed.
 - d. General Instruction for online payment:
 - The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.
 - Status of NEFT/RTGS payment through challan for a bid may take time for bank settlement which is updated in 24 Hrs. (Approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.

- In case actual BID SECURITY amount as per NIT is more than the one shown in E-tender portal, bidders will have to opt for NEFT/RTGS mode (Challan Mode) . In that case the total actual BID SECURITY amount is to be paid only through NEFT/RTGS mode (Challan Mode).
- e. Refund / Settlement of BID SECURITY Amount:
 - For unsuccessful bidders, BID SECURITY amount submitted against the tender shall be refundable automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
 - For successful bid(s), BID SECURITY will be refundable from WBSEDCL authority after completion of tendering process and following due procedures.
 - The bank account used for payment of BID SECURITY by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the bank A/C from which the payment of BID SECURITY has been initiated.
 - For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033-40267512/13 since payment gateway facility used by E-tender portal is maintained by ICICI.
- f. Successful bidder(s) shall have to mandatorily create vendor id through WBSEDCL web portal Vendor Corner, if not created earlier.

Tenders are to be submitted online and intending bidders are to download the tender documents from the website stated above. This is the only mode of collection of tender documents. Details of submission procedure are given in "Instructions to Bidders".

2. Both Technical Bid and Financial Bid should be submitted in technical and financial folder concurrently duly digitally signed by the Bidders through the website <https://wbtenders.gov.in>.
3. Technical Document and Financial Bid should be submitted online on or before 20.02.2024 up to 18.00 Hrs
4. The FINANCIAL OFFER of the prospective bidders will be considered only if the TECHNICAL DOCUMENT of the bidders found qualified by the Tender Inviting Authority (WBSEDCL). The decision of the Tender Inviting Authority (WBSEDCL) will be final and absolute in this respect. The list of Responsive and Non-Responsive Bidders will be displayed in the website.
5. Eligibility criteria for participation in the tender:
 - 5.1 **Technical Requirement:-** Bonafide, experienced & resourceful contractors of Govt., Semi Govt., Govt. undertaking Organizations, Govt. Enterprises, Other Licensee of States, etc. who is technically qualified & have successfully completed similar nature of work having value not less than **50%/40%/30% (Fifty/Forty/Thirty percent) of the estimated cost in a Single/Two/Three contracts respectively during last 7 (Seven) years.**
 - 5.2 **Commercial Requirement:-** a) Average annual turnover during last three years shall not be less than **50% of the estimated cost.** b) Working capital in the year preceding the year of bid submission shall not be less than 30% of the estimated cost. c) Available credit facility shall also be added to working capital certified by Bank for working capital as noted in (b) above. d) Annual audited Financial Report for last three years to be submitted for verification i.r.o bidders for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT return along with related enclosures (Form 3CA and Form 3CB) for last three years.
 - 5.3 All intending bidders are required to produce valid electrical contractor's license with supervisory competency certificate suitable for above mentioned work.
 - 5.4 All intending bidders are required to also produce the following:-
 - i) Valid copies of GST No,
 - ii) ESI registration wherever applicable with current challan (DEC 23)
 - iii) Current Challan for depositing Professional Tax (PT) (DEC 23)
 - iv) EPF registration certificates with current challan (DEC 23)
 - v) Certificate of compliance of statutory obligations (to be documented through e-filing).
 - vi) Copy of IT return for last three financial years (20-21, 21-22, 22-23), PAN Card, as applicable.

- vii) Documents in support of credential: Copy of orders & Completion Certificate
viii) Performance Certificate as Prime Contractor for execution of similar nature of works for last Seven years and details of works in hand.
ix) Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt./PSU in which the bidder is involved, the party is concerned and disputed amount, wherever applicable (Annexure iii).
- 6.0 No mobilization / secured advance will be allowed.
- 7.0 Bids shall remain valid for a period not less than 180 (One hundred eighty) days after date of bid opening of tender. Bid valid for a shorter period shall be rejected by the Tender Inviting Authority as non-responsive. If the bidders withdraws the bid before the period of bid validity without giving any satisfactory explanation for such withdrawals, the Bid security as deposited will be forfeited forthwith without assigning any reason thereof –

- 13.0 The bids Conditional/Incomplete tender shall not be accepted under any circumstances.
- 14.0 Canvassing in connection with the tender is strictly prohibited. At any stage during scrutiny, if it is found that the credential or any other paper which the bidder has uploaded or submitted is found incorrect/manufactured/ fabricated, that bid will be considered as non-responsive and outright rejected with forfeiture of Bid Security and action will be taken as per Rule.
- 16.0 The Tender Inviting Authority (WBSEDCL) does not bind itself to accept the lowest bidder and reserves the right to accept or reject, split any / all offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by the Bidder at any stage of the Bidding. Tender inviting Authority (WBSEDCL) also reserves right to accept/cancel/withdraw the concerned NIT in full or part due to unavoidable circumstances and no claim in this respect shall be entertained.
