The bidder will be a single entity / sole proprietorship firm, partenership firm, Co-operative Society, Public or Private Limited Company preferably having experience and proven track record in execution of design, engineering and construction of steel suspension bridge in hilly areas.

The bidders should also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the BOQ item and as described in Technical Specification and should have financial capacity as mentioned hereunder.

The bidder shall satisfactorily meet the following qualifying criteria:-

## 4.1 TECHNICAL CRITERIA:

- a) The bidder must have successfully completed similar nature of works\*\* in hill area during last 7 (seven) years i.e., upto 30.11.2022 subject to fulfillment of the following criteria
  - (i) Three similar completed works each costing not less than 40% of the total estimated cost in a single contract

#### OR

(ii) Two similar completed works each costing not less than 50% of the total estimated cost in a single contract,

#### OR

- (iii) One similar completed work costing not less 80% of the total estimated cost in a single contract.
- b) \*\*'Similar nature of works' shall mean design, engineering & construction of steel suspension bridge alongwith other associated works as per the annexed BOQ and technical specification complete in all respect.
- c) The bidder would require expertise in all ancillary work required to complete suspension bridge construction alongwith anchors and other associated structures.
- d) The bidders must have satisfactorily completed works of similar nature as per above eligibility criteria under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government of India as well as of the neighbering countries. Copy of order/s alongwith completion Certificate/s from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. Value of work done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the bidder along with the credential.
- e) The bidders shall have to submit valid copies of Professional Tax deposit challans for the last six months, E.P.F. Registration certificate, GST Registration certificate (GSTIN), Employees' State Insurance (ESI) registration certificate, PAN Card and Income Tax Return Acknowledgement for the Assessment Years 2021-22, 2020-21 & 2019-20, Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Limited Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License).

- f) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- g) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.

### 4.2 COMMERCIAL CRITERIA:

### a) TURNOVER

The bidder's Minimum Average Annual Turnover (MAAT) for last 03 (three) Financial Years (2018-19, 2019-20 and 2020-21) shall not be less than 30% of the estimated cost. The bidder shall submit reports on the financial standing i. r. o. solvency of Bidder (Company/ Firm) as certified by bankers, audited annual reports on accounts with auditors' certificate for companies registered under Companies Act and Tax Audit Report for Partnership Firms for Financial Years 2018-19, 2019-20 and 2020-21.

Net worth for the each of the last 03 (three) Financial Years (2018-19, 2019-20 and 2020-21) should be positive. Net worth means the sum total of the paid up capital and free reserves (excluding reserves created out of revaluation) reduced by aggregate value of accumulated losses (including debit balance in profit and loss account for current year) and intangible assets.

### b) WORKING CAPITAL

- (i) Working capital in the year preceding the year of bid submission shall not be less than 30% of the estimated cost.
- (ii) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in 3.2 (b) (i) shall be judged by adding available credit facility and working capital taken together.
- (iii) Annual audited financial report for last three years to be submitted for verification in respect of bidder for whome audit of accounts is mandatory.

N.B.: Any mou/temporary agreement/joint ventures/ consortium/any other arrangement to constitute an entity having no statutory registration certificates (Non-permanent Establishment) beyond the above entities (mentioned in clause-h above) for the purpose of applying as prospective bidder will not be considered as valid document.

- 5. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNO-COMMERCIAL BID of The bidder is found qualified by WBSEDCL. The decision of WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Techno-Commercial Bid will be displayed in the website.
- 6. A prospective bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If he is found, to have applied severally, in a single job, all his offers will be rejected for that job.
