- All categories of intending Bidders shall have to submit valid copies GST Registration (ii) certificate, PAN Card and Income Tax Return Acknowledgement for the Assessment Year 2020-21. Trade License in respect of the prospective bidder, 2022-23, 2021-22, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License

The bidder should have necessary license in execution of Pest control job.

- 4. Tender documents will not be issued/ received by post.
