2. No agent is allowed to participate in the Tender. Authorization certificate i.r.o the material from the OEM is to be submitted by the bidder along with other credential documents and type test report (CPET/CPRI) in favour of OEM is required.
3. WBSEDCL reserves its right to take decision keeping its financial interest. The Purchase Policy of WBSEDCL along with the provisions of Vendor Rating & Holiday Listing, as effective from 01.09.2012 and the subsequent amendment effective from 18.03.2013 will be applicable.
