Online percentage rate e-tender in two part for the under mentioned work is invited by the Project Manager, Rammam Hydel Project, St-II, WBSEDCL from eligible, bonafide, experienced and resourceful Contractors of State/Central Govt., State/Central Govt. undertaking, statutory bodies constituted under the statute of Central Govt, as per specifies terms, conditions and specifications & satisfying other technical criteria as set forth in this document for providing requisite services for execution of the under mentioned work at Rammam Hydel Project, St-II in the district of Darjeeling, West Bengal.

1. Intending bidder should download the tender documents from the website <http://www.wbtenders.gov.in> directly with the help of Digital Signature Certificate, without any cost. The amount of Earnest Money Deposit (EMD) as mentioned above shall be deposited by the bidder electronically: online - through his net banking enabled bank account maintained at any bank or offline: through any bank by generating NEFT/ RTGS challan from the e-tendering portal. Intending Bidder will get the Beneficiary details from e-tender portal. In case of actual EMD amount as per NIT is more than the one shown in e-tender portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
2. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed by the bidder through the website <http://www.wbtenders.gov.in>. (Details of which has been narrated in Section-II i.e. "Instruction to Bidders") as per Schedule stated in Sl. No. 8.
3. **Eligibility criteria for participation in tender:**
The pre-qualification will be subject to bidder's fulfillment of the qualification criteria set forth and stipulated hereunder & substantiated by authentic and relevant information and details. The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items as mentioned hereunder.

The bidder shall satisfactorily meet the following qualifying criteria:

3.1 TECHNICAL CRITERIA:

- a) A bidder shall be considered technically eligible, with experience of having successfully completed similar works during last 7 years (after 31st January'2018) subject to fulfillment of the following criteria:
- i. Three similar completed works costing not less than the amount equal to 40% of the estimated cost.
Or
 - ii. Two similar completed works costing not less than the amount equal to 50% of the estimated cost.
Or
 - iii. One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- b) Similar nature of works for work under Sl. No. 3.1 (a) shall mean, for Repair & Maintenance of Desilting Basin of Intake of Hydro Power Project, Repair & Maintenance/Construction/Renovation of Quarters/Buildings, Construction/Restoration of Protection wall/Sausage wall/Drain/Culvert/Bridges, Repair & Maintenance/Construction/Renovation of road.
- c) The bidders must have satisfactorily completed works of similar nature as per above eligibility criteria under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government. Copy of order/s along with completion Certificate/s from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the bidder along with the credential.
- d) The bidders shall have to submit valid copies of up-to-date Professional Tax Payment Certificate, Professional Tax deposit challans for last six months, E.P.F. Registration Certificate, GST registration certificate along with last 3(Three) years GST return, PAN Card and Income Tax Return Acknowledgement for Assessment Year, 2022-23, 2023-24, 2024-25. Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License, MSME registration certificate of the bidders, if available, ESI registration Certificate.
- e) Neither prospective Bidder nor any of the constituent partners had been debarred to participate in any Tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- f) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the bidder is found qualified by WBSEDCL. The decision of WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
5. **No mobilization advance and secured advance will be allowed.**
6. A prospective bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If he is found, to have applied severally, in a single job, all his offers will be rejected for that job.
7. Bid shall remain valid for a period of 180 (one hundred eighty) days from the date of opening of Price Bid or revised Price Bid, if any. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

10. The intending bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by WBSEDCL. WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any bidder at any stage of Bidding.
11. Prospective bidders are advised to note carefully the minimum qualification criteria as mentioned in 'Sl. no. 3' of this section and as stated in Section – II before tendering the bids.
12. Exemption from submission of Earnest Money Deposit (EMD) shall not be allowed under any circumstances.
13. Conditional / Incomplete tender will not be accepted under any circumstances.
14. The intending bidders are required to quote the rate online (Details of which has been narrated in Section-II).
15. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
16. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
17. **The eligibility of a bidder will be ascertained on the basis of the documents submitted by a bidder in support of eligibility criteria. If any document submitted by a bidder is incorrect or false at any stage, his bid will be out rightly rejected and legal action will be taken against him.**
18. The participating bidder may please note that the successful bidder shall have to submit an Indemnity Bond in the prescribed format before commencement of work.
19. WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
20. WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
