a) A bidder shall be considered technically eligible, with experience of having successfully completed similar work during last 7 years subject to fulfillment of the any of the following criteria:

ii) Two similar completed works each costing not less than 50% of the total estimated cost (without GST) in a single contract.

iii) One similar completed works each costing not less 80% of the total estimated cost (without GST) in a single contract.

- The bidders shall have to submit valid copies of up to date Professional Tax Payment Certificate, Professional Tax deposit challans for last six months, E.P.F. Registration Certificate, GST Registration Certificate, ESI Registration Certificate, GSTIN, PAN Card and Income Tax Return Acknowledgement for Assessment Year 2021-22, 2022-23, 2023-2024 Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License). Bidders without valid E.P.F. registration no. will be summarily rejected. [Non-statutory Documents].
 - d) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
 - e) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.

3.2 <u>COMMERCIAL CRITERIA</u>:

a) TURNOVER

Average annual turnover of the bidder during last three (3) financial years shall not be less than 30% of the estimated cost (without GST).

b) WORKING CAPITAL

- (i) Working capital in the year proceeding the year of bid submission shall not be less than 30% of the estimated cost (without GST).
- (ii) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in 3.2 (b) (i) shall be judged by adding available credit facility and working capital taken together.
- (iii) Annual audited financial report for last three years to be submitted for verification in respect of bidder for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT returns along with related enclosures (Form 3CA/3CB) for last five years if applicable.
