- i) At least one year experience in day-to-day electro-mechanical maintenance or construction of Hydel Power Station (minimum 5 MW Capacity), 132 KV Substation & Hydraulic Gates against a single contract value of minimum ₹ 30.0 (Thirty) lakhs.
- ii) Valid Electrical Contractor's License with Supervisory Competency Certificate suitable for 132 KV level.
- Annual turnover of not less than 60.0 (Sixty) lakhs in any particular year during last three years (Balance sheet for the last three financial years shall have to be furnished);
- iv) Employees' Provident Fund & GST Registration;
- v) Trade License with up to date P. Tax Challan;
- vi) PAN Card & IT Return for the last three years;
- vii) MSME Certificate of the bidder if available; and
- viii) Partnership Deed in case of Partnership Firm.
- b) Neither prospective Bidder nor any of the constituent partners have been debarred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertakings/Enterprise etc. during the last 05 (five) years prior to the date of this e-NIT. Such debarment will be considered as disqualification towards eligibility.
