DCR of such transfer of money will not be issued thereafter in any case.

Eligibility criteria for participation in tender:

- (i) All categories of intending Bidders who have satisfactorily completed at least one work of similar nature under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government of executed value not less than 50% of the annual estimated cost in a single contract after 1st January'2017. Completion Certificate indicating Estimated Amount, Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer / District Engineer / Divisional Engineer or equivalent rank and above will be treated as valid credential. [Non-statutory Documents]
- ii) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax Payment Challan, P.F. Registration number, GST Registration details, E.S.I. Registration no (for execution of works in ESI coverage area), PAN Card and Income Tax Return for Assessment Year 2018-19, 2017-18, 2016-17, Trade License in respect of the prospective Bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License). - iii) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department / Semi Govt. /Govt.
