Duplicate Carbon Receipt (DCR) of such transfer need be collected from the office of the Manager (F&A), TCFHP in the month of transfer itself for their future reference and claim/Refund if any. DCR of such transfer of money will not be issued thereafter in any case.

2. Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Bidder through the website https://wbtenders.gov.in. (Details of which has been narrated in 'Instruction to Bidders') as per Schedule stated in SI. No. 8.

3. Eligibility criteria for participation in tender:

- (i) All categories of intending Bidders who have satisfactorily completed at least one work of similar nature under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government of executed value not less than 50% of the estimated cost in a single contract on or after 1st January, 2017. Completion Certificate indicating Estimated Amount, Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Statutory Body of Central / State Government will be treated as valid credential. [Non-statutory Documents]
- (ii) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax Payment Challan, P.F. Registration number with current challan deposition slip, GST Registration details with current challan deposition slip, E.S.I. Registration no. if applicable, PAN Card and Income Tax Return for Assessment Year 2019-20, 2018-19 & 2017-18. License in respect of the prospective Bidder such as Trade License for Proprietorship Firm; Partnership Deed and Trade License for Partnership Firm; Incorporation certificate and Trade License for Ltd Company; Society Registration copy and Trade License for Co-operative Society is to be submitted. - (iii) Neither prospective Bidder nor any of the constituent partners had been debarred to participate in any Tender by any Government Department / Semi Govt. /Govt. Undertakings / Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. - (iv) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents]
- 4. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. List of Technically Qualified Bidders will be uploaded in the website.

5. No mobilization advance and secured advance will be allowed.

- 6. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm or Ltd. Company or Co-Operative society etc. *Multiple participations from one single identity are not allowed.*
- 7. The Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the date of opening of Financial Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
- 11. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section 'A' before tendering the bids.
- 12. Exemption from deposition of earnest money (EMD) shall not be allowed under any circumstances.
- 13. Conditional / Incomplete tender will not be accepted under any circumstances.
- 14. The intending Bidders are required to quote the rate online.
- 15. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- 16. The Canvassing in connection with tender submitted is strictly prohibited.
- 17. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria.
