A. NOTICE INVITING e-TENDER

The Addl. CE and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL invites e-tender (Submission of Bid through online) for the work detailed below

- A. Name of the work:** Overhauling of Rope Drum & rope pulley associated with the Grab Mechanism, Rectification of the Rail line misalignment, Supply of 02 nos. ungalvanized, IWRC of size 20mm diameter 6X36 construction 1770 tensile strength as per IS 2266:02, Remodeling of existing roof & Painting of the outside body with anti-corrosive Paint & Primer of the Trash Rack Cleaning Machine (TRCM) installed at PS-I, TCFHP, WBSEDCL including supply of Tools & Tackles making arrangement of scaffoldings etc.
- B. Completion Time:** 45 days from the date of handing over the site. The successful bidder shall have to submit a detailed Bar Chart showing the different activities to be taken up at different points of time & completion thereof adhering strictly to the time schedules of completion of whole job within 45 (Forty Five) days from the date of handing over the site.
- C. Estimated Cost:** ₹ 9,18,200/- (Rupees nine lakh eighteen thousand two hundred only). GST will be paid extra as per statute.

F. Eligibility Criteria: The intending bidders must have:

- i) Successfully completed similar work i.e. overhauling of gates / hoist / rope drum etc. against a single contract value of minimum executed amount (excluding of GST /Service Tax) of 50% of the estimated cost. Work completed in last seven years of due date of submission will only be considered.
- ii) Average annual financial turn over during the last three years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost. (Balance sheet, P&L for the last three financial years shall have to be furnished);
- iii) Employees' Provident Fund
- iv) GST Registration certificate
- v) ESI No.
- vi) Up to date P. Tax clearance certificate.
- vii) PAN Card
- viii) IT Return for the last three years
- ix) Valid Trade License.

TERMS OF THE TENDER:

1. Intending bidder should download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate (DSC). Necessary cost of tender documents (tender fees) and Earnest Money Deposit (EMD) should be remitted separately as has been narrated in 'Instruction to Bidders'.

The instruments for cost of tender & earnest money deposit should be documented and scan copy of the aforesaid documents are to be uploaded through said website as per schedule stated in (Instruction to the bidders). Registration no (for execution of works in ESI coverage area), PAN Card and Income Tax Return for Assessment Year 2019-20, 2018-19, 2017-18, Trade License in respect of the prospective Bidder. Proprietorship Firm: (Trade License). Partnership Firm: (Partnership Deed, Trade License). Limited Company: (Incorporation certificate, Trade License). Co-operative Society: (Society Registration certificate, Trade License). [Non-statutory Documents].

2. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.



3. No mobilization advance and secured advance will be allowed.
4. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
5. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the last date of submission of Financial Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
10. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
11. Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances.
12. Conditional / Incomplete tender will not be accepted under any circumstances.
13. The intending Bidders are required to quote the rate online at www.wbtenders.gov.in



14. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
15. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
16. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
17. The participating bidders may please note that the successful bidder shall have to submit an Indemnity Bond in the prescribed format before commencement of the work.
18. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
