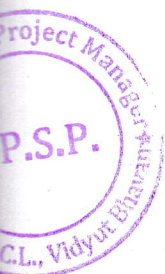

02. Sale of Bid Documents : On & from 1<sup>st</sup> September 2022 to 13<sup>th</sup> September 2022 between 11.00 hrs. & 14.00 hrs. **on all working days** (except Saturday, Sunday and State Govt. holidays) from the Office of the Chief Engineer & Project Manager, Purulia Pumped Storage Project against payment of cost of bid document(non-refundable) in cash.
03. Receipt of Bid : Upto 14.00 hrs. On 14<sup>th</sup> September 2022
04. Opening of Bid : Technical bid opening date: 14<sup>th</sup> September 2022 at 15.30 hrs  
Price bid opening date : To be intimated later (After qualifying technical bid)
05. List of Documents (self attested) to be submitted along with enclosed application format (in duplicate) for bid document
- I) Completion Certificate indicating estimated amount, Executed amount, certificates for date of completion of the work (Original may be produced for verification) and detailed communicational address along with contact number of the client should be submitted by the bidder (enclosed 'Application for Bidders'). Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. Performance to be considered as a prime contractor for execution of work.
  - II) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax receipt Challan upto the period 31.03.2022, E.P.F. Registration number (non-statutory), GSTIN, PAN Card and Income Tax Return for last three financial years, Trade License in respect of the prospective Bidder.
  - III) In case, the bidder is a small Service Provider, he has to furnish one certificate along with the bid documents in the following manner to get exemption from GSTIN:  
*"That our firm is a small service provider within the threshold limit i.e aggregate turnover does not exceed Rs. 20.00 lac"*
06. Other terms & conditions of the Bid :
- a) The bid shall remain valid for **120(One hundred and twenty) days** from the date of opening of Price Bid/Revised Price Bid, if any.
  - b) Exemption from deposition of earnest money shall not be allowed under any circumstances. The mode and amount must be in conformity with requirements failing which the bid is liable for rejection without opening other covers.
  - c) The intending bidder may please note that prevailing labour Acts i.e Contract labour (Regulation & Abolition) Act 1970, EPF & MP Act 1952, Workmen's compensation Act 1923, Building and other Construction Worker's welfare cess Act, 1996, Building and other Construction Worker's (Regulation of employment and condition of service) Act, 1996, Payment of bonus Act 1965 & wages Act 1936, Minimum wages Act, 1948 and the rules thereof must be complied by them, as applicable
  - d) The intending bidder may please note that an amount equal to **1% of contract amount** will be deducted from the R/A bills/ Final bill on account of "The building and other construction workers welfare Cess Act, 1996" apart from other statutory deductions.

- e) The tax imposed under GST shall be charged and recovered separately as per applicable laws.
- f) The **successful bidder** shall be required to execute an Agreement on a non-judicial stamp paper of Rs 100/- with the company with all related documents for satisfactory execution of the work and an Indemnity Bond is to be submitted by him in the prescribed format of company before commencement of the work.
- g) In case the last date of receipt of application, issue, or date of receipt and opening of tender are declared as holiday, the respective dates shall be treated as postponed to next working day correspondingly.
- h) No conditional /incomplete tender will be accepted under any circumstances. Any extraneous conditions will be treated as non-responsive.
- i) The Bids must be submitted as below :

Cover-I (Earnest money): Earnest Money is to be submitted under this cover.

Cover-II & Techno-Commercial bid : This envelop shall contain credentials and documents in support of Must Conditions, qualifying and commercial requirements as specified along with bid document duly signed.

Cover-III & Price bid : This envelop shall contain complete price Schedule.

Price offer should be submitted strictly as per formatted schedule of bid document. Name of the work, Tender No, due date and time of Tender submission should be clearly written on the front side of the above covers.

Cover- IV : All the above three covers shall be placed inside Cover-IV and shall be submitted properly sealed super scribing 'Tender No', Name of the work, due date, & 'No. of covers inside' with mentioning bidder's name & seal.

- j) The Price bid of the prospective bidder will be considered only if the Technical Bid of the bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of successful bidder will be displayed in the Notice Board.
- k) Bidders shall ensure that all pre-requisites are duly fulfilled by them and if there be any dispute regarding non-submission of any document, WBSEDCL reserves the right to cancel the bid unilaterally without assigning any reasons.
- l) The bidder is expected to examine carefully all instructions, conditions, forms schedules terms, annexure, specifications and drawings of the bidding document. bids, which are determined to be not substantially responsive to the requirement of the bidding document, may lead to rejection.
- m) The eligibility of a bidder will be ascertained on the basis of the documents submitted by a bidder in support of eligibility criteria. If any document submitted by a bidder is either incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
