


Fig-1: Cross Arm Strap




Fig 2: Ball Clevis








Fig-3: Socket Tongue






Fig. 5: DEAD END CLAMP (COMPRESSION TYPE) WITH JUMPER CONE FOR ACSR PANTHER CONDUCTOR
