All intending Bidders are required to produce valid copies of GST Registration, Professional Tax (PT) deposit challans for the last month, copy of IT return for last three financial years ie 2019-20, 2020-21, 2021-2022 assessment year, PAN, Documents in support of Credential such as copy of orders and completion certificates (to be documented through e-filing).
  7. No mobilization/secured advance will be allowed.
  8. Constructional Labour welfare Cess @ 1% (one percent) of cost of construction will be deducted from every Bill. All other statutory levy/Cess as applicable will have to be borne by the contractor & the rate in the schedule of rates are inclusive of all such taxes and Cess as stated above. The estimated cost is exclusive of GST. GST will be admissible as per prevailing rates and rules in force.

  - RTGS/NEFT Payment:** On selection of RTGS/NEFT as the payment mode. The e Procurement portal will show a pre filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e Procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.
