- Experienced & resourceful manufacturers/suppliers/Distributors undertaking Organizations, Govt Enterprises of WBSEDCL / other Power Utilities / Govt. / Semi Govt. Departments / Govt. undertaking Organizations / Govt. Enterprises who have successfully completed similar nature of work having value not less than 50% (fifty percent) of the estimated cost in a single contract during last 5 (Five) years.
- All intending Bidders are required to produce valid copies of GST Registration, Professional Tax (PT) deposit challans for the last month, copy of IT return for last three financial years ie 2019-20, 2020-21, 2021-2022 assessment year, PAN, Documents in support of Credential such as copy of orders and completion certificates (to be documented through e-filing).
 - No mobilization/secured advance will be allowed.
 - Constructional Labour welfare Cess @ 1% (one percent) of cost of construction will be deducted from every Bill. All other statutory levy/Cess as applicable will have to be borne by the contractor & the rate in the schedule of rates are inclusive of all such taxes and Cess as stated above. The estimated cost is exclusive of GST. GST will be admissible as per prevailing rates and rules in force.

9. Bids shall remain valid for a period not less than 180 (One hundred eighty) days after date of financial Bid opening of tender. Bid valid for a shorter period shall be rejected by the Tender Inviting Authority as non- responsive. If the tenderer withdraws the bid before the period of bid validity without giving any satisfactory explanation for such withdrawals, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
10. The bidder shall select the tender to bid and initiate payment of EMD. Following payment option are available for paying EMD amount through online mode:
 - a) Net banking through Payment Gateway.
 - b) RTGS/NEFT Payment: On selection of RTGS/NEFT as the payment mode. The e Procurement portal will show a pre filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e Procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.
 - c) Submission of EMD through BG: For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e tender portal and upload scanned copy of BG in the EMD exemption document upload section .Physical copy of BG Shall be submitted at the office of tender inviting authority as per respective clauses of NIT.
11. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing Bid and entering into an agreement for the work / works as mentioned in the NIT, before submitting offer with full satisfaction. The costs for visiting the working site shall be at the bidder's own expense.
12. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of the Bid, no cost of Bidding shall be reimbursable by the Tender Inviting Authority. Lowest bidder may has to submit a sample of the material for approval within **07 (seven) days** after opening of the tender. Placement of order is subject to approval of the sample by 'Divisional Sample approval committee'.
21. DELIVERY: The materials shall have to be delivered at site (Jalpaiguri Divisional Store, Mohitnagar, Jalpaiguri) free of all incidental charges.
22. LIQUIDATED DAMAGES: Upon non completion of work within the stipulated time, a liquidated damage @ 0.5% per week of delay or part thereof should be imposed subject to a maximum of 5% of the total order value.
