Terms & Conditions

1. <u>Techno-Commercial Requirements of the Bidder (Minimum eligibility criteria):</u>

The intended bidder must have: -

- A) Valid PAN, GSTIN, PTPC.
- B) Submitted GST return for last 24 months.
- C) Experience of successful completion of similar works in last 7 (seven) years (on or after 1.1.2018) with fulfillment of any of the following criteria (work done as a part of Consortium and/ or Joint Venture shall not be considered).
 - i. 3 projects, each having project cost not less than Rs. 28 lakh (excluding GST) in a single contract
 - ii. 2 projects, each having project cost not less than Rs. 40 lakh (excluding GST) in a single contract or,
 - iii. 1 project, having project cost not less than Rs. 68 lakh (excluding GST) in a single contract.

 (Note: For interpretation of 'similar work' under sl. no. 1.A.c) above, new installation/ repair & renovation related to firefighting and/ or fire detection/ alarm system will be considered)
- D) Average annual turnover during last 3 F.Y. not less than Rs. 34 lakh.
- E) Working capital in the F.Y. preceding the year of bid submission not less than Rs. 34 lakh (to be judged by adding the available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).
- F) Submission of annual audited financial report for last 3 F.Y. years (for whom audit of accounts is mandatory)

Copy of IT returns with related enclosures (Form 3CA & Form 3CB) for last 5 years (for whom audit of accounts is not mandatory).

- G) Declaration on not being blacklisted/ holiday listed/ ineligible for corrupt and fraudulent practices/ financially insolvent or the bidder's business and its assets and properties not being a subject matter for pending adjudication before any court of law or Tribunal or no Corporate Insolvency Resolution Process (CIRP) being instituted against the bidder or bidder not being declared as Insolvent by any Court of law or Tribunal. - 2. Necessary documents as specified in IB.6 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.

- 3. For e-filling of bids, intending bidder shall download bid documents from the website: https://wi directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to D concurrently, duly digitally signed, in the same website within scheduled time mentioned in the bid.
- 4. Earnest Money shall be mandatorily deposited online through the website: https://wbetenders.gov.in vi banking via Payment Gateway or RTGS/NEFT Payment or through BG, as elaborated in the Section "Instruction Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque. No exemption of the earnest money is allowed. Any tender without earnest money will be rejected without opening.
- 5. GST shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
- 6. WBSEDCL does not bind itself to accept the lowest bid and reserves the right to reject any or all the bids or part thereof and also the right to split the work at its discretion without assigning any reason whatsoever.
- 7. No employee of WBSEDCL and its entrusted consultant (Southern Engineering & Consultancy Services) shall be attached with any of the intending bidders as a proprietor/ partner or Board member or any other capacity that may invite conflict of interest.
