## **Terms & Conditions**

- 1. <u>Techno-Commercial Requirements of the Bidder (Must Conditions):</u>
  - 1.1 Valid PAN, GSTIN, EPF Code, ESI registration.
  - 1.2 GST returns of last 2 (two) financial years, IT returns of last 5 (five) financial years.
  - 1.3 Successful completion of either civil or electrical works of building nature in last 7 (seven) years (work completed on or after 1.1.2018) with credential value under any Govt./ Private Client with fulfillment of any of the following criteria:
    - A) 3 (three) works, each having executed value not less than Rs. 1.54 Cr. excluding GST in a single contract or,
    - B) 2 (two) completed works, each having executed value not Jess than Rs. 1.92 Cr. excluding GST in a single contract or,
    - C) 1 (one) completed work, having executed value not less than Rs. 3.08 Cr. excluding GST in a single contract.
  - 1.4 Working capital in the financial year preceding the year of bid submission not less than Rs. 1.15 Cr. (to be judged by adding available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).
  - 1.5 Average annual turnover during last 3 (three) financial years not less than Rs. 1.15 Cr.
  - 1.6 Solvency certificate from Bank.
  - 1.7 Self-undertaking from the bidder in the given format that they are not ineligible for corrupt and fraudulent practices and/ or holiday listed/ blacklisted/ found financially insolvent under Govt. of India/ Govt. of W.B.
  - 1.8 JV & consortium will not be allowed.
  - 1.9 No employee of WBSEDCL and its entrusted consultant (VBridge) shall be attached with any of the intending bidders as a proprietor/ partner or Board member or any other capacity that may invite conflict of interest.
- 2. Necessary documents as specified in IB.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.

- 3. For e-filling of bids, intending bidder shall download bid documents from the website: https://wbtenders.gov.in directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.
- 4. Earnest Money Deposit shall be mandatorily deposited online through the website https://wbetenders.gov.in via Net-banking via Payment Gateway or RTGS/NEFT Payment or through BG, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque etc. There is no tender cost for this tender.
- 5. GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules.1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
- 6. WBSEDCL doesn't bind itself to accept the lowest bid and reserves the right to reject any or all the bids or part thereof and also the right to split the work at its discretion without assigning any reason whatsoever.
