##### 1. Techno-Commercial Requirements of the Bidder (Must Conditions):

The intended bidder must have:-

- 1) Valid PAN, GSTIN, PTPC.
- 2) GST returns (FY 2023-24, 2024-25), IT returns (FY 2021-22, 2022-23, 2023-24).
- 3) Working capital in the FY 2023-24  $\geq$  ₹ 20 lakh (to be judged by adding available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).
- 4) Successfully completed similar work during last 5 (five) years (work completed on or after 1.4.2020) with executed value not less than 50% of the respective estimated value in a single contract under any Central or State Govt. Dept./ Govt. Enterprise/ Govt. UT or Statutory bodies excluding GST (Any civil works, either construction or maintenance nature, will be treated as 'similar work').

2. Necessary documents as specified in 1B.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.
3. For e-filling of bids, intending bidder shall download bid documents from the website: <https://wbetenders.gov.in> directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.
4. Earnest Money Deposit shall be mandatorily deposited online through the website <https://wbetenders.gov.in> via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque/BG etc. There is no tender cost for this tender.
5. GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
6. WBSEDCL doesn't bind itself to accept the lowest bid and reserves the right to reject any or all the bids or part thereof and also the right to split the work at its discretion without assigning any reason whatsoever.
