1. Techno-Commercial Requirements of the Bidder (Must Conditions):

The intended bidder must have:-

 - 2) GST returns for the FY: 2023-24, 2024-25.
 - 3) IT returns for the FY: 2021-22, 2022-23, 2023-24.
 - 4) Successfully completed similar work during last 7 (seven) years (completed on or after 1.4.18) with executed value \geq 40% of the estimated value in a single contract excluding GST (Any civil or waterproofing works, either new or maintenance, will be treated as 'similar work' for interpretation of this clause)
2. Necessary documents as specified in IB.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.
 3. The selected bidder shall have to execute the job with the materials and authorized applicator of any of the pre-selected manufacturers: SIKA / FOSROC / BERGER.

Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.

Earnest Money Deposit shall be mandatorily deposited online through the website <https://wbetenders.gov.in> via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document.  6. GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
