- 3) Successfully completed similar work during last 5 (five) years (completed on or after 1.4.2020) with executed value ≥ 50% of the respective estimated value excluding GST in a single contract under ay, x Central of State Govt. Dept./ Govt. Enterprise/ Govt. UT or Statutory bodies (Any civil work of either new or maintenance nature will be treated as 'similar work' for interpretation of this clause).
- Necessary documents as specified in 18.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.

Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.

It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
