- 2) GST returns for last 2 (two) financial years.
- 3) IT returns of last 3 (three) financial years.
- 4) Successfully completed similar work during last 5 (five) years with executed value not less than 50% of the respective estimated value in a single contract under any Central of State Govt. Dept./ Govt. Enterprise/ Govt. UT or Statutory bodies excluding GST.

(Note: Any work of firefighting system/ FDA system, either new work or maintenance nature, will be treated as 'similar work' for interpretation of this clause)

- 2. Necessary documents as specified in IB.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.
- 3. For e-filling of bids, intending bidder shall download bid documents from the website: https://wbtenders.gov.in directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.

There is no option for offline submission of EMD through DD/Pay order/Banker's cheque etc. or BG. There is no tender cost for this tender.

It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
