B. Work Credential :

The bidder must have executed AMC order / orders under Central/State Govt., Central/State Govt undertakings having approx. annual value(without GST) in a year Rs 1.70 lakhs. Such order is needed to be completed within last three years, counted from the due date of submission of the instant NIT. Such orders and its successful completion are needed to be of state/ Central Govt., state/ Central Govt. Undertakings, Statutory bodies constituted under the statute of Central / State Govt.

2. Necessary documents as specified in IB.3 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.
