## Terms & Conditions

1. Minimum Techno-Commercial Requirements of the Bidder:

Final selection of successful bidder shall be made through 'QCBS' method, based on total marks obtained by the bidders in techno-commercial as well as price evaluation, as elaborated in Section "Instructions to Bidders" of the bid document However, the bidders must fulfill the following minimum requirements to be eligible for consideration for such evaluation:

- a) Deposition of appropriate sum of earnest money.
- b) Valid PAN, GSTIN and Professional tax payment certificate (PTPC).
- c) Last 2 (two) year's GST return.
- d) Valid empanelment of architect & engineer in Bidhannagar Municipal Corporation.
- e) Successful completion of consultancy services in similar building projects under Govt./ Govt. undertaking/ Govt.
   Enterprises (residential/ office/ other Govt. buildings), having consultancy charges not less than Rs. 10 lakh in a single contract.
- f) Average annual turnover of at least Rs. 6.0 lakh during last 3 (three) financial years.

A bidder must score at least 70 (seventy) marks in techno-commercial evaluation to be able to proceed to the final stage of selection. Else, they will be eliminated in the techno-commercial stage itself and their price bid shall not be opened.

- 2. For e-filling of bids, intending bidder shall download the bid documents from the website: <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a> directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently duly digitally signed, in the same website within time schedule below.
- 3. Earnest Money Deposit shall be mandatorily deposited online through the website <a href="https://wbetenders.gov.in">https://wbetenders.gov.in</a> via Netbanking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque/BG etc. There is no tender cost for this tender.
- 4. GST & labour cess are not to be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules.
