#### 1. Techno-Commercial Requirements of the Bidder (Must Conditions):

- Experience of having successfully completed similar works during last 7 years with fulfillment of any of the following criteria:
  - 3 completed works, each costing not less than 35% of the estimated value or,
  - 2 completed works, each costing not less than 45% of the estimated value or,
  - One completed work, costing not less than 75% of the estimated value."
- Valid PAN, GSTIN, GST return of last 2 (two) years, current PTPC.
- Average annual turnover during last 3 years not less than 30% of the estimated value.
- Working capital in the year preceding the year of bid submission not less than 30% of the estimated value (to be judged by adding available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).
- Submission of annual audited financial report for last 3 years (for whom audit of accounts is mandatory)
