- Techno-Commercial Requirements of the Bidder (Must Conditions):
 - Experience of having successfully completed works during last 7 (seven) years with fulfillment of any of the following criteria:
 - a) 3 civil works, each costing at least 40% of the estimated value in a single contract, or,
 - b) 2 civil works, each costing at least 50% of the estimated value in a single contract or,
 - c) One civil work, costing at least 80% of the estimated value in a single contract.
 - At least one of the above credentials should be of similar office remodelling job, costing at least 50% of the estimated value in a single contract. C.
 - Valid PAN, EPF code, ESI registration, GSTIN, GST returns of last 2 (two) years, current PTPC.
 - Working capital in the year preceding the year of bid submission not less than 30% of the estimated value (to be judged by adding available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted). E.
 - Average annual turnover during last 3 years not less than 30% of the estimated value.
 - Submission of annual audited financial report for last 3 years and copy of IT returns with related enclosures (Form 3CA & Form 3CB) for last 5 years.

Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule below.

- GST & labour cess are not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules.
