1. Techno-Commercial Requirements of the Bidder (Must Conditions):

- Experience of having successfully completed similar work of value not less than 50% of the estimated value in a single contract during the last 7 (seven) years (Note: For interpretation of 'similar work' under this clause, new installation/ repair & renovation related to firefighting and/ or fire detection/ alarm system will be considered).
 - Valid PAN, GSTIN, last 2 (two) years' GST return, current PTPC, IT return of last 3 (three) years.
- For e-filling of bids, intending bidder shall download bid documents from the website: <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule below.
 - Earnest Money Deposit shall be mandatorily deposited online through the website <https://wbtenders.gov.in> via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/ Pay order/ Banker's cheque/BG etc..
 - No mobilization advance and secured advance will be allowed.
 - GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
 - WBSEDCL doesn't bind itself to accept the lowest bid and reserves the right to reject any or all the bids or part thereof and also the right to split the work at its discretion without assigning any reason whatsoever.
