- 1. Techno-Commercial Requirements of the Bidder (Must Conditions):
 - A. The intended bidder must have :-
 - 1) Valid PAN, GSTIN, PTPC.
 - 2) GST returns for last 2 (two) financial years.
 - 3) IT returns of last 3 (three) financial years.
 - 4) Successfully completed similar work during last 5 (five) years with executed value not less than 50% of the estimated cost in a single contract under any Central of State Govt. Dept./ Govt. Enterprise/ Govt. UT or Statutory bodies excluding GST.

(Note: Any civil works, either construction or maintenance nature, will be treated as 'similar work' for interpretation under sl. no. 4 above)

- 2. Necessary documents as specified in IB.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.
- 3. For e-filling of bids, intending bidder shall download bid documents from the website: https://wbtenders.gov.in directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.
- 4. Earnest Money Deposit shall be mandatorily deposited online through the website https://wbetenders.gov.in via Net-banking via Payment Gateway or RTGS/NEFT Payment or through BG, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque etc. There is no tender cost for this tender.
- 5. GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
