- 1. Techno-Commercial Requirements of the Bidder (Must Conditions):

  - B. Valid PAN, GSTIN, last 2 (two) years' GST return, current PTPC, IT return of last 3 (three) years.
- 2. For e-filling of bids, intending bidder shall download bid documents from the website: https://wbtenders.gov.in directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule below.
- 3. Earnest Money Deposit shall be mandatorily deposited online through the website https://wbetenders.gov.in via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. - 5. GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
