Techno-Commercial Requirements of the Bidder (Must Conditions):

- 3) IT returns of last 3 (three) financial years.
- 4) Successfully completed similar work during last 5 (five) years with executed value not less than 50% of the respective estimated value in a single contract under any Central of State Govt. Dept./ Govt. Enterprise/ Govt. UT or Statutory bodies excluding GST.

(Note: Any civil or gardening works, either construction or maintenance nature, will be treated as 'similar work' for interpretation of this clause)

- Necessary documents as specified in IB.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria as above.
- For e-filling of bids, intending bidder shall download bid documents from the website: https://wbtenders.gov.in
 directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.
- 4. Earnest Money Deposit shall be mandatorily deposited online through the website https://wbetenders.gov.in via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque/BG etc. There is no tender cost for this tender.
- 5. GST is not included in the estimated cost and shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills.
