1. Minimum Eligibility Criteria of the Bidders

- A. Valid PAN, GSTIN, ESI registration, GST returns of FY 2022-23, 2023-24.
- B. Average annual turnover during the FY 2021-22, 2022-23, 2023-24 ≥ Rs. 81 lakh.
- C. Working capital in the FY 2023-24≥ Rs. 81 lakh (to be judged by adding the available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).
- D. Experience of successful completion of similar works (new work of firefighting system/ maintenance of firefighting systems) in last 8 (eight) years from the date of issue of this NIT with fulfillment of any of the following criteria (work as a part of Consortium and/ or Joint Venture not to be considered).
 - i. 3 (three) jobs, project cost ≥ Rs. 81 lakh each excluding GST in a single contract/ package, or
 - ii. 2 (two) jobs, project cost ≥ Rs. 108 lakh each excluding GST in a single contract/ package, or,
 - (one) job, project cost ≥ Rs. 135 lakh each excluding GST in a single contract/ package.

- 3. Earnest Money shall be deposited either online through the above website or through BG, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque. No exemption of the earnest money is allowed. Any tender without earnest money will be rejected without opening.
- 4. GST shall not be considered in the quoted rate of the bidders. It shall be payable extra as per prevailing rules. 1% labour cess under BOCWWC Act 1996 shall be deducted from the contractor's bills. It shall not be paid extra and shall have to be included in the quoted rate of the bidders.
- WBSEDCL does not bind itself to accept the lowest bid and reserves the right to reject any or all the bids or part thereof and also the right to split the work at its discretion without assigning any reason whatsoever.
- 6. No employee of WBSEDCL and its entrusted consultant (Southern Engineering & Consultancy Services) shall be attached with any of the intending bidders as a proprietor/ partner or Board member or any other capacity that may invite conflict of interest.
