6. **Submission of bid.:** The intending bidder shall submit their bid along with the signed documents in the form of:
 - a. 1st envelope containing: Envelope named **Technical bid**, super-scribing name of work, tender notice no., and date of opening containing.
 - i. Signed copy of NIT.
 - ii. Document in support of eligibility criteria as per NIT.
 - b. 2nd envelope named **financial bid**, super-scribing name of work, tender notice no., and date of opening containing **Annexure -I**, for Price Bid.
 - c. The 3rd envelope super-scribing name of work, tender notice no., date of opening and contain 1st, and 2nd envelope only.
7. **Validity of bid:** Bid shall remain valid for a period not less than 120 (one hundred twenty) days from the date of last date of submission of the bid.
8. **Opening of Bid:** Submitted bid shall be opened by the tender committee on date and time as per NIT.
 - Technical bid shall be opened first. Financial bid of only technically qualified bid shall be opened. Technically unqualified bids will be summarily rejected. Lowest price in totality will be guiding factor to decide successful bidder.
9. **Award of contract:**
 - a. Qualified bidder will be notified by the authorized official through acceptance letter/purchase order/letter of award.
 - b. The notification of award will constitute the formation of the Contract.
10. **Payment:**
 - a. 100 (hundred) % of the ordered value along with full taxes and duties shall be made after successful completion of work and submission of tax invoice and challan in triplicate for due certification by the controlling officer of the work for payment processing in due course.
 - b. **Warrantee:** Standard warrantee clause of manufacturer shall have to extend to WBSEDCL.
11. **Completion:**
 - a. Within 30 days from the date of issue of order.
 - b. The power contactor as per specification shall be collected by our authorized representative at Mal Dist. Jalpaiguri or at Siliguri. The cost for transportation up to Mal Dist. Jalpaiguri or at Siliguri shall be borne by bidder.
 - c. The power contactor shall be packed for safe transportation to site.
 - d. The material shall be delivered at Jhalung, Po- Jaldhaka Hydel project Kalimpong 734503 addressed to the consignee.

12. Liquidated Damage:

- a. If the bidder fails to complete the work successfully within the time specified in the Contract or any extension thereof, WBSEDCL shall recover from the bidder as liquidated damages a sum of half percent (0.5%) of the contract value of works for each calendar week of delay or part thereof of delay subjected to the **Force Majeure**.
- b. The total recovery against liquidated damage shall not exceed ten percent (10%) of the contract value of the work.
- c. An extension of time without imposition of liquidated damage may be granted for delay in execution of work, provided there is no fault whatsoever on the part of the bidder. Such extension may only be granted on the basis of application to be submitted by the bidder before expiry of delivery period which has to establish that the extension of time required by him was not due to his fault.

13. Force Majeure:

- a. The Bidder shall not be liable to pay any liquidated damage for delay/failure to perform the contract for reasons of force majeure such as acts of God, acts of the public enemy, acts of Governments, fire, flood, epidemics, quarantine restriction, strikes, freight embargos and provided that the bidder shall within 10 (ten) days from the beginning of such delay notify the Company in writing of the cause of delay. The Company shall verify the fact and grant such extension as found to be justified without imposing liquidated damage.
- b. WBSEDCL shall not be responsible or liable to pay any compensation for any interruption in your work due to strike, lockout, riot, earthquake, flood, cyclone or civil commotion or any other force of accident due to any reason beyond control. WBSEDCL shall not be held responsible to or liable to pay for any interruption in your work arising out of resistance from the local public due to any resistance towards work.

14. Inspection & Testing:

- a. WBSEDCL may depute engineer at his own cost to inspect the power contactor at successful bidder's works before dispatch.
- b. The successful bidder shall inform in advance regarding readiness of power contactor for inspection.
- c. The rejected materials shall have to be replaced by the successful bidder and subject to re-inspection.
- d. The successful bidder shall pay Rs. 500 per visit to the purchaser for re-inspection.

15. Company's Right to Terminate the Contract:

- a. If the bidder neglects or fails to proceed with the work proportionate to the schedule time of completion of the work or fails to complete the work within schedule time for completion or within the extended time approved by the WBSEDCL, WBSEDCL shall have right to terminate the order/ letter of intent after giving notice in writing to the bidder. If the bidder fails after 14 (fourteen) days' of such notice, to proceed with the work in the manner notified WBSEDCL shall terminate the contract.
- b. WBSEDCL may take possession of the work and may engage other agency to complete the work. Extra cost, if incurred to get the unfinished work done through other agency, will be realized from him, from his pending bills and security money.
- c. If the contract is terminated as above, the bidder shall have no claim for compensation against the Company for any loss or deterioration of any materials that he may have collected or engaged or entered into on account of the work.
