- 3. Eligibility criteria for participation in tender:
  - (i) All categories of intending Bidders who have satisfactorily completed at least one work of similar nature under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government of executed value not less than 50% of the estimated cost in a single contract on or after 1<sup>st</sup> Jan, 2017. Completion Certificate indicating Estimated Amount, Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Statutory Body of Central / State Government will be treated as valid credential. [Non-statutory Documents]
  - ii) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax Payment Challan, P.F. Registration number, GST Registration details, E.S.I. Registration no. if available, PAN Card and Income Tax Return for Assessment Year 2018-19, 2017-18 & 2016-17. License in respect of the prospective Bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License) is to be submitted.   - iii) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department / Semi Govt. /Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility.
