

Following amendments has been made to the tender document: -

The payments will be made after deducting Ld/penalties if any, based on the SLA and other MIS reports	GTC.13.1. Advance payment will be made according to clause GTC.13.3." "GTC.13.3. 20% of the amount in respect of the BOQ item having start date 01.12.2023 shall be paid in the beginning of 1 st Quarter on submission of documentary evidence for proof of purchase of service from OEM for respective period. Rest of the amount shall be divided into 7 quarter and payable in quarterly advance mode i.e. in the beginning of each quarter considering clause GTC.13.4. During advance payment of each quarter, the MIS/other reports of previous quarter shall be submitted by the vendor for the calculation of SLA/LD and accordingly, LD/SLA shall be deducted. In the last quarter, for any LD/SLA, the same shall be adjusted from the PBG lying with WBSEDCL.
