Online e-tenders in two-part system with item-wise basis are invited by Project Manager, Rammam Hydel Project, Stage - II, WBSEDCL, Lodhamahat, Darjeeling-734201 from original equipment manufacturer, authorized dealer of the OEM or any other reputed agency dealing with the OEM having requisite credentials for the work as specified below.

- Name of Work: "Supply including testing at manufacturers works, delivery and unloading of 132 KV Outdoor Type Current Transformer of Ratio: 600-300/1-1-1A as specified in <u>Chapter-4</u>: <u>Technical specification of the tender document and other related matters at Rammam Hydel</u> Project, Stage-II, WBSEDCL".
- 2. Earnest Money: Rs. 33,000.00/- (Rupees thirty-three thousand only).
- 3. Price Basis: The Price shall be quoted on FOR RHP Store site basis including all charges towards freight & transit insurance, packing & forwarding etc. GST will be paid extra as per actual. The quoted prices shall remain FIRM during the currency of the contract.
- 4. Eligibility Criteria: The Bidder must possess minimum eligibility criteria as mentioned:
 - a. Bidder must be an original equipment manufacturer. Authorized dealer of the OEM or any other reputed agency dealing with the OEM may also participate in this tender.
 - b. For the item to be quoted i.e., 132 KV CT, the OEM should have minimum existence in design, manufacture and supply of similar or higher rated items to WBSEDCL / WBSETCL / WBPDCL / NHPC/ Power Grid / NTPC or any other Power Utility / Govt. undertaking Company of India within the last seven (07) years reckoned from the date of publication from the date of NIeT.
 - e. For the item to be quoted i.e., 132 KV CT, the OEM must provide experience & good performance certificate of similar or higher rated voltage class, for at least two nos. of supplies to WBSEDCL / WBSETCL / WBPDCL / NHPC/ Power Grid / NTPC or any other Power Utility / Govt. undertaking Company of India within the last seven (07) years reckoned from the date of publication from the date of NIeT.
 - d. The authorized dealer/ dealing agency must arrange documentary evidence from OEM for fulfilling the criteria as mentioned in Clause No. 4 (b) and 4 (c) above. Any bid submitted by a dealer/dealing agency without such documentary evidences will be summarily rejected.
 - e. The bidders Minimum Average Annual Turnover (MAAT) for best one (01) year out of the last five (05) financial years should be INR 13,20,000.00 (Rupees thirteen lakh twenty thousand only).
 - f. Valid GST Registration Certificate and GSTR-3B for last one year.
 - g. PAN Card.
 - h. Up to date P. Tax clearance certificate.
 - i. IT Return for the last three years.
 - License in respect of prospective bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership deed, Trade License), Ltd. Company (Incorporation Certificate, Trade License).

The Bidder shall produce copy of the documents in support of their respective eligibility criteria, along with a duly filled Experience Record as per proforma enclosed at Chapter - 5, Attachments & Technical Annexures. Any discrepancies found in this by the tender inviting authority may lead to rejection of the bid and forfeiture of the earnest money.

Bids are to be submitted online only. All the documents in support of bid are also to be scanned and uploaded along with the tender document. Bids submitted/sent by any other mode will not be accepted.

- 8. Validity: The offer against tender should remain valid for a minimum period of 180 days from the next day of opening of the tender. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
- Conditional / Incomplete tender will not be accepted under any circumstances.
- 10. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice and the earnest money deposited will be forfeited.
- 11. The eligibility of a Bidder will be ascertained based on the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is found incorrect / manufactured / fabricated or false at any stage, his Tender will be rejected with forfeiture of earnest money and legal action may be taken against him.
- 12. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves the right to take decisions keeping its financial interest.
- 13. WBSEDCL reserves the right to:

Amend the scope of work to be tendered.

Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and

Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.

- 14. WBSEDCL reserves the right to assess the bidders' capacity and capability to perform the contract and may relax the qualifying requirements at any stage, if required. No price preference will be allowed to any agency/contractor based on the size of the company or its geographic location. Co-operative Society / MSME will not be considered with separate status.
- 15. The Bidder at the Bidder's own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the Bidder's own expense.
- 16. Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Bidder through the website https://wbtenders.gov.in and should be submitted online on or before as per the 'Date &Time Schedule'. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
