1.0 SCOPE OF WORK:

The specification/contract is intended to cover execution of Supply & Delivery of 271nos. 33 kv-V BRACKET for PCC Pole 9m long Divisional Store, Dinhata Division

2.0 Quantity

3.0 SUBMISSION OF TENDER:

The tender will be submitted in two bid systems i.e. Techno-Commercial bid & financial bid, online only through the Website www.wbtenders.gov.in

4.0 ELIGIBILITY CRITERIA OF THE BIDDER:

4.1 Technical:

- 4.1.1 A bidder shall be considered technically eligible, with experience of having successfully completed works in Similar related field during last 7 years subject to fulfillment of the following criteria.
- a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

Or

- b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost.
- c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- 4.1.2. All materials should be as per the drawing and specifications as given below:-
 - 1. Specification as mention in diagram
 - 2. Minimum Weight of V BRACKET 19.5 Kg.(please ignore weight mention on diagram)

4.2 Commercial & Financial:

- 4.2.1 The average annual turnover of the bidder during last three years shall not be less than 30% of the estimated cost. (Annexure-I).
- **4.2.2** Working capital in the year, proceeding the year of bid submission shall not be less than 30% of the estimated cost.

- 9. The bidder is expected to examine carefully all instructions, conditions, forms schedules terms, annexure, specifications and drawings of the bidding document. Bids, which are determined to be not substantially responsive to the requirement of the bidding document, may lead to rejection.
- 10.All bids in the range of -20% to -80% of the estimated cost shall furnish an Additional Performance Security in the form of Bank Guarantee (Annexure-VII) from any scheduled Bank, which shall be equal to 10% of the Tendered amount.
- 11. Earnest Money (EMD): Earnest Money Deposit shall be submitted through online mode through the e-Tendering portal (https://wbtenders.gov.in). All offline instruments like Bank Draft, Pay Order etc. will be stopped for e-tender procurement. In case of unsuccessful/rejected bids, the EMD shall be refunded directly from the e-Tendering portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms.

12.2. The Performance guarantee is to be submitted to the Controlling Officer of the work Immediately on receipt of the order.

13. One Sample of Each Material is to be submitted at Dinhata Division Office, WBSEDCL, situated at Power House Campus, Dinhata, Coochbehar – 736135 , physically within the closing date of tender. The tag with the sample should contain the name of the sample as well as the name of the vendor/bidder, for a valid tender, sample has to be approved by the Divisional Authority. The approval or rejection of sample will be communicated via mail/electronically subsequently. The technical evaluation of bidders, whose samples aren't approved, will not be opened & henceforth they will be deemed disqualified. Rejected samples can be taken away. After PO is awarded, the awardees can adjust the sample with the delivered material lot & the remaining materials can be taken back by the respective vendors.

In exceptional cases

Submission of EMD through BG: For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT. EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG)in full. Partial payment through online mode and remaining submission through BG is not allowed.

B) GENERAL INSTRUCTIONS FOR ONLINE PAYMENT OF EMD:

i) The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.

ii) Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicacy.

iii) In case actual EMD as per NIT is more than the one shown in E-tender Portal, bidders will have to optfor NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
