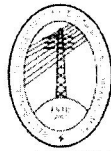

3. Eligibility criteria for participation in tender:

- i. The bidder must also have successfully completed **similar works** (**defined below*) during last 7 (Seven) years from the date of this Notice Inviting Tender under the authority of State/Central Government, State/Central Government Undertakings, Statutory Bodies constituted under the statute of Central/State Government, subject to fulfillment of the following criteria:

(a) Three similar completed works each having executed cost not less than 40% of the total estimated cost in a single contract,

OR

(b) Two similar completed works each having executed cost not less than 50% of the total estimated cost in a single contract,

OR

(c) One similar completed work each having executed cost not less than 80% of

- ii. **PAYMENT CERTIFICATE** of Submitted Credential for Works Executed in Departments Other than WBSEDCL: To fulfill the eligibility criteria mentioned in Clause No. 3 (i) of this NIT, submission of a copy of the payment certificate is mandatory for any credential submitted in support of work executed under any department or statutory body of the Central or State Government, other than WBSEDCL.
