INVITATION FOR BID

1. SCOPE OF WORK: -

Supply, Installation and Commissioning of 60 MT capacity fully electronic Lorry Weigh Bridge of pitiless type with 16 X 3 Mtr platform. The two Longitudinal main beams should be of each 500mm ISMB single length piece without any welding from SAM strong to the office of the control of t any welding from SAIL/TISCO, top desk plates of not less than 10mm thickness, the eight load cells should be of Double Ended Share Beam type each load cell should not be less than 45 MT capacity with latest PC, Digitizer and printer including civil works for the weighbridge i.e. foundation, approach ramps with Speed Breakers on turnkey basis atZonal Store Santipur of W.B.S.E.D.C.L.

(i) DESPATCH: The supplier shall deliver the equipment/materials suitably packed to Zonal Store, Santipur of W.B.S.E.D.C.L.at the address mentioned previously. The materials are to be booked by Road only and the same should suitably be packed and fully insured against all risks and delivery of the consignment as per dispatch instruction to be communicated in due course. Immediately after dispatch of materials/equipment by Road, the successful L1 bidder shall notify the purchaser and consignee officer about value of consignment, weight and dimension of consignment by emailand the hard copies of such relevant documents must be sent by post to facilitate smooth delivery of the consignment at destination. Materials/equipment shall have to be dispatched within the stipulated period of the order.

(ii) DELIVERY &INSTALLATION:

a) Supply of the material including Erection, commissioning, including verification and stamping by Weights and Measure shall be completed within 120 (One hundred and twenty) days from the date of issuance of Purchase Order.

CHECKING OF MATERIALS/EQUIPMENT AFTER DELIVERY:

The materials delivered to consignee stores will be subjected to inspection / testing in presence of authorized representative of the supplier if any discrepancy/ dispute in quality arises the supplier shall have to replace the same at the Supplier's cost and WBSEDCL reserves the right to take any penal action whatsoever without any further reference.

2. **ELIGIBILITY CRITERIA OF THE BIDDER: -**

TECHNICAL ELIGIBILITY CRITERIA OF THE BIDDER

The bidder must have successfully completed similar nature of works during last seven years (date of completion of work should be on or after 14.03.2017) subject to fulfillment of the following criteria:

Three similar completed works each of the contracts comprising of executed value not less than the i. amount equal to 40 % of the estimated cost i.e. Rs. 9,18,000.00

Or

Two similar completed works each of the contracts of executed value not less than the amount equal ii. to 50 % of the estimated cost i.e Rs. 11,47,500.00

Or

One similar completed work of executed value not less than the amount equal to 80 % of the iii. estimated cost ie Rs. 18,36,000.00

N.B.-Completion Certificates indicating Name of the Work, Ordered Amount, Executed Amount, date of commencement and completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer/Assistant Engineer or equivalent rank and above will be treated as valid credential. Also uploading of copy of work order and schedule of work as supporting documents of completion certificate is mandatory.

COMMERCIAL REQUIREMENT:

i)Average annual turnover during last three financial years(FY 2020-21, 2021-22 and 2022-23 shall not be less than 30% of the estimated cost.

ii) Working capital in the year, preceding the year of bid submission (i.e. in financial year-2022-23) shall not be

than 30% of the estimated cost.

iii)In case documents certifying credit facility (Refer Annexure II) from a scheduled Bank is submitted, the requirement given in clause no (ii) shall be judged by adding available credit facility and working capital taken together.

iii) Annual audited Financial Report for last three financial years to be submitted for verification in respect of bidders for whom audit of account is mandatory. For those whose audit of accounts is not mandatory they shall submit copy of IT returns along with related enclosures (Form3CA/3CB and particulars are reported in the Form 3CD u/s 44AB of Income Tax Act'1961) for last five financial years (ie 2018-19, 2019-20, 2020-21, 2021-22 and 2022-23).

Necessary documentary evidence as detailed herein above shall have to be uploaded by the bidder to ascertain the commercial eligibility criteria.

3. OTHER STATUTORY REQUIREMENTS (TO BE UPLOADED): -

The Bidder shall furnish the following documents-

(vi)Trade License in respect of the prospective Bidder, Proprietorship Firm (Valid Trade License), Partnership Firm

(Partnership Deed, Valid Trade License and Power of Attorney), Ltd Company (Incorporation certificate i.e. MOA and AOA, Valid Trade License and Power of Attorney), Co-operative Society (Society Registration Copy, Valid Trade License and Power of Attorney)

(vii) Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt /PSU in which the

bidder is involved the party's concerned and disputed amount.

(viii)Up-to-date Trade License along with manufacturing license/registration from legal Metrology authorities.

NB: Any MOU/Temporary arrangement to constitute an Entity having no statutory Registration Certificates (Non-Permanent Establishment) beyond the above entities mentioned in 3(vi) for the purpose of

applying as prospective bidder will not be considered as valid document.

- 4. Bidders willing to take part in the process of e-tendering are required to obtain Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under CCA, Govt of India (viz. nCode Solution, Safescrypt, e-Mudhra). DSC is given as a USB e-Token. After obtaining the Digital Signature Certificate (DSC) from the approved Certifying Authority they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website.
- 5. Earnest Money: Earnest Money Deposit shall be submitted through online mode only in the e-Tendering portal (https://wbtenders.gov.in).

The Bidder shall deposit the requisite earnest money through online mode only (Bank Name- ICICI BANK LTD, A/C No. 193405000657, Account Title- West Bengal State Electricity Distribution Company Ltd., Account Type – Current, IFSC Code – ICIC0001934, MICR Code-700229096, ICICI Bank Ltd., Block-A, ECOSPACE BUSINESS PARK, RAJARHAT, KOLKATA-700156). Following payment options are available for online payment of EMD, for the intending bidders,

- i) Net-banking through Payment Gateway.
- RTGS/NEET Payment: On selection of RTGS/NEET as the payment mode, the e-procurement portal will show a pre-filled challan having the details to process RTGS/NEET transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEET payment using his bank account. Once the payment is made, the bidders will come back to e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEET process to be completed.
- 6. In case of unsuccessful/rejected bids, the EMD shall be refunded directly from the e-Tendering portal. However, for successful bids, the EMD will be refunded by WBSEDCL as per norms, the bidder shall submit along with the offer necessary documents in support of credential (related to the tender) towards financial capabilities to the extent of the estimated financial capacity of the bidder.
- 7. WBSEDCL reserves its right to take decision keeping its financial interest. The provisions of Purchase Policy along with the Works Policy of WBSEDCL with subsequent amendment will be applicable.
- 8. If the offer is submitted without or inadequate Earnest Money, the bid will not be opened. In case of incomplete offer, the tender will be liable for rejection and Earnest Money Deposit will be forfeited.

- The offer against tender should remain valid for a minimum period of 180 days from the date of opening of 9. financial bid. However, WBSEDCL may considering the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
- Any evidence of unfair Trade Practices including over charging, price fixing, cartel etc. as defined in various 10. statutes, will automatically disqualify the bidders.
- WBSEDCL is not bound to accept the rate of lowest bidder and reserves the right to cancel any or all the tenders 11. unilaterally.
- Any bidder against whom FIR/Complaint is lodged with Police by WBSEDCL or blacklisted by any unit of 12. WBSEDCL or any Govt. dept. / Autonomous bodies / Govt. PSU / Govt.Institutesfrombusiness shall not be eligible to participate in the bidding process.
- Other information as well as terms and conditions, which are not covered above, will be available in Instructions 13. to Bidders, General Conditions of Contract of this tender along with the Revised Purchase Policy and Works Policy of WBSEDCL.
- Price Bid of a bidder will be considered only if his Techno-commercial Bid is found acceptable by WBSEDCL. 14. Decision of WBSEDCL will be final and absolute/binding in this respect. The list of techno-commercially qualified bidders will be displayed in the said website in due course.
- Conditional / Incomplete tender will not be accepted under any circumstances. 15.

NOTE:

- 1. WBSEDCL reserves the right to reject or accept any Bid or part thereof or all Bids received at its sole discretion without assigning any reason (s) whatsoever.
- WBSEDCL reserves the right to go to divisible contract, if necessary.
- 3. WBSEDCL is not necessarily bound to accept the lowest offer.
- 4. Submission of Bidding Documents will not be construed to mean that such bidder is automatically considered qualified.
- Tender submitted after expiry of scheduled date and time shall not be considered. 5.
- 6. The Bidding Documents are not transferable under any circumstances.
- 7. No interest shall be payable for Bid Guarantee.
- 8. Any extraneous conditions will be treated as non-responsive.
- 9. The Bids must be submitted in prescribed proforma only.
- 10. Formation of any Cartel, may lead to the cancellation of tenders with period measures as necessary and WBSEDCL reserves the right to take such unilateral decisions without further notice to anyone.
- 11. Bidders shall ensure that all pre-requisites are duly fulfilled by them and if there be any dispute regarding nonsubmission of any document, WBSEDCL reserves the right to cancel the Bid unilaterally without assigning
- 12. The bidder is expected to examine carefully all instruction, conditions, forms, schedules terms, annexure, specifications and drawings of the bidding document. Bids, which are determined to be not substantially responsive to the requirement of the bidding document, may lead to rejection.
- 13. The document uploaded by the bidders should be legible otherwise the bid will be rejected without any
- 14. Bid evaluation will be conducted only on the basis of final documents uploaded by the bidders within last date and time of online bid submission. Under no circumstances the bidder will be given any further chance to upload any document (online) after opening of technical bid.
- 15. In case the quoted rate by the bidders is in the range of (-)20% to (-) 80% of the estimated amount, the contractor shall furnish an Additional Performance Security in the format given in Annexure - "VIII" which shall be equal to 10 % of the tendered amount. (As per memo no: 82(5)-POW-13099/3/2018-SECTIONS (POWER) dated 05.07.2021 of Govt. of West Bengal, Department of Power). The Additional Performance Security shall be submitted in the form of Bank Guarantee issued by any Scheduled Commercial Bank as per enclosed format before placement of award of contract.
