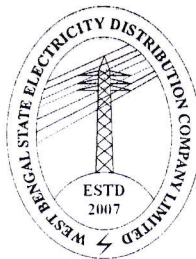

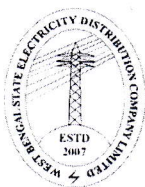

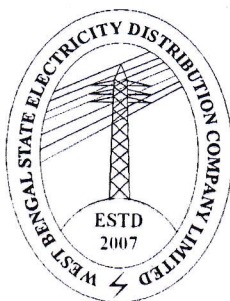

Chief Engineer & Project Site-In-Charge, Purulia Pumped Storage Project, WBSEDCL e-tender in two parts (Techno-commercial bid & Financial Bid) from experienced, bonafide and resourceful Companies/ Organizations having previous experience in execution of similar nature work & satisfying other techno-commercial criteria as set forth in this document for providing requisite services for execution of the following works at Purulia Pumped Storage Project Site, Bagmundi in the district of Purulia, West Bengal for the work detailed below (Submission of Bid through online):

1. Intending bidder should download the tender documents from the website <http://www.wbtenders.gov.in> directly with the help of Digital Signature Certificate. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. (Details of which has been narrated in Section-II).
2. Both **Techno-Commercial Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed by the bidder through the website <http://www.wbtenders.gov.in>. (Details of which has been narrated in Section-II) as per Schedule stated in Sl. No. 8.

3. ELIGIBILITY CRITERIA FOR PARTICIPATION IN TENDER:

The pre-qualification will be subject to bidder's fulfillment of the qualification criteria set forth and stipulated hereunder & substantiated by authentic and relevant information and details. The bidders shall also have experience and proven track record in taking up and completion of the work of magnitude and nature similar to the items and should have financial capacity as mentioned hereunder.

The bidder shall satisfactorily meet the following qualifying criteria: -

3.1 TECHNICAL CRITERIA:

- a) A bidder shall be considered technically eligible, with experience of having successfully completed similar work during last 7 years subject to fulfillment of the any of the following criteria:
 - i) Three similar completed works each costing not less than 40% of the total estimated cost (without GST) in a single contract.
 - OR
 - ii) Two similar completed works each costing not less than 50% of the total estimated cost (without GST) in a single contract.
 - OR
 - iii) One similar completed works each costing not less 80% of the total estimated cost (without GST) in a single contract.
- b) Similar nature of works for work under sl. no. 1 shall mean similar type of work such as any civil works that contributes towards major financial involvement of the bid.

- c) The bidders must have satisfactorily completed works of similar nature as per above eligibility criteria under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government. Copy of order/s along with completion Certificate/s from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. Value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by The bidder along with the credential.
- i) The bidders shall have to submit valid copies of up to date Professional Tax Payment Certificate, Professional Tax deposit challans for last six months, E.P.F. Registration Certificate, GST Registration Certificate, ESI Registration Certificate, GSTIN, PAN Card and Income Tax Return Acknowledgement for Assessment Year 2020-21, 2021-22, 2022-23, Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License). **Bidders without valid E.P.F. registration no. will be summarily rejected.** [Non-statutory Documents].
- d) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt./ Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.
- e) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. A declaration in this respect has to be furnished by the prospective bidder.

3.2 COMMERCIAL CRITERIA:

a) *TURNOVER*

Average annual turnover of the bidder during last three (3) financial years shall not be less than 30% of the estimated cost (without GST).

b) *WORKING CAPITAL*

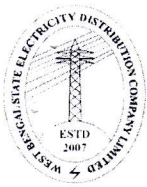
(i) Working capital in the year proceeding the year of bid submission shall not be less than 30% of the estimated cost (without GST).

(ii) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in 3.2 (b) (i) shall be judged by adding available credit facility and working capital taken together.

(iii) Annual audited financial report for last three years to be submitted for verification in respect of bidder for whom audit of accounts is mandatory. For those whose audit of accounts is not mandatory, they shall submit copy of IT returns along with related enclosures (Form 3CA/3CB) for last five years if applicable.

4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNO-COMMERCIAL BID** of The bidder is found qualified by WBSEDCL. The decision of WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Techno-Commercial Bid will be displayed in the website.

5. No mobilization advance and secured advance will be allowed.

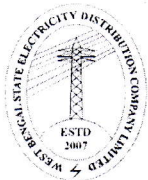

6. A prospective bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If he is found, to have applied severally, in a single job, all his offers will be rejected for that job.
7. Bid shall remain valid for a period not less than **180 (one hundred eighty) days** from the last date of submission of Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

9. The bidder at his own cost and responsibility may visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender.
10. The intending bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by WBSEDCL. WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any bidder at any stage of Bidding.
11. Prospective bidders are advised to note carefully the minimum qualification criteria as mentioned in 'Sl. no. 3' of this section and as stated in Section – II before tendering the bids.
12. Exemption from submission of Bid Guarantee/Earnest Money Deposit (EMD) shall not be allowed under any circumstances.
13. Conditional / Incomplete tender will not be accepted under any circumstances.
14. The intending bidders are required to quote the rate online (Details of which has been narrated in Section-II).
15. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
16. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
17. **The eligibility of a bidder will be ascertained on the basis of the documents submitted by a bidder in support of eligibility criteria. If any document submitted by a bidder is incorrect or false at any stage, his bid will be outrightly rejected and legal action will be taken against him.**

18. The participating bidder may please note that the successful bidder shall have to submit an Indemnity Bond in the prescribed format before commencement of work.
19. The instant Annual Maintenance Contract may further be extended for a suitable period if desired by WBSEDCL beyond 1 (one) year subject to satisfactory performances by the executing agency at the originally quoted rate and terms and conditions of the contract.
20. WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
21. WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
