Instructions to Bidders

A. General Guidance for e-Tendering

Instructions and guidelines for tenders for electronic submission of the tenders online have been annexed to assist contractors in participating in e-Tendering.

1. Registration of Vendors:

Any contract or wishing to participate in the e-Tendering process must enroll and register with the Government e- Procurement system by logging on to <https://wbtenders.gov.in>(the web portal).

The contractor should click on the link for the e-Tendering site as provided on the web portal.

2. Digital Signature Certificate (DSC):

Each contractor is required to obtain a **Class-II or Class-III Digital Signature Certificate (DSC)** for the submission for the submission of tenders from the approved service provider of the National Informatics Centre (NIC), upon payment of the requisite amount.

Details are available on the website mentioned in Clause-2oftheGuidelinestoBidder. The DSC will be provided as a USB e-Token.

3. Downloading Tender Documents:

Vendors can search and download the **NIT (Notice Inviting Tender)** and **Tender Documents** electronically from their computer once they log on to the website mentioned in Clause-2using the Digital Signature Certificate(DSC). This is the only mode of collection of Tender Documents.

4. Submission of Tenders:

Tenders must be submitted online via the website, in **two folders** for each work:
